**Belize Bus Association v. Floralia Ltd!** Association opposes newcomer's Road Service Permits

The Belize Bus Association (BBA) is making a move against newcomer Floralia Limited and has filed a Judicial Review for the court "to quash" various Road Service Permits that were awarded to the new bus company.

In a letter addressed to the Chief Transport Officer and the Minister of Transport Hon Rodwell Ferguson, the BBA—represented by Barrow and Williams law firm—reads, "We have filed an application for permission for judicial review" to declare illegal and quash various Road Service Permits "awarded" to Floralia Limited by the Transport Board.

That application also seeks a stay of the last decision of the Board granting permits to Floralia Limited regarding, among others, Dangriga Belize City runs.

On Thursday, BBA's Secretary Ewart Metzgen told The Reporter that while he would prefer to withhold comments on the matter since the paperwork has already been filed and the matter is now

In the third week of the Russian invasion of her smaller, weaker neighbor Ukraine, the devastation from the air bombardment and non-stop rocket attacks on cities and towns has been barbaric.

Friends from the west have been sending military support and help. But the United States, the North American Treaty Organization (NATO), the U.K. and the European Union have declined to intervene directly, out of concern that this two-nation conflict could balloon out of control to become a world war involving the possible use of nuclear weapons.

President Putin of Russia knows this and he is determined to bring Ukraine to her knees by hook or by crook. He has not ruled out nuclear action. In fact, he is keeping the West at bay by pointing to his nuclear options.

The United States and NATO have done the same. The war is taking a heavy toll on the people of Ukraine. Two million persons, mostly women and children have fled from their warbattered country, creating the biggest exodus of refugees since World War II.

Defending Ukrainians have put up unbelievable resistance, delaying a 20 mile long column of tanks and troops which has snaked its way into Ukraine to surround and isolate Kiev, the capital. Most western observers are now convinced that even if Russia succeeds in conquering the port City of Odessa in the south and the capital Kiev in the east, her troops will not be able to hold on to their gains. They will suffer death from a thousand cuts.

Economic sanctions imposed by the West have bitten deeply into the Russian economy, preventing her from using any of her large reserves because these have been frozen, and may be needed to pay for war reparations.

With the Russian economy plunging, western nations expect that Russia will not be able to keep up her war effort for much longer. She will then have to look for a way out of her dilemma, but no one knows how long this will take.

Russian troops fighting in Ukraine need food and water and other logistical support. The old saying that an army marches on its belly is still true, even in this jet age of instant communication. There is evidence that the

Russian overland supply line has been buckling under stress.





Delizean bus own-**D**ers have decided to strike against high fuel costs that have diminished their profits, **Belize Bus Association** (BBA)'s Secretary Ewart Metzgen told The Reporter Thursday.

"Our membership has decided that we will strike," Metzgen explained. "We are in the process of putting together our plan of action, and after we are through with that then we will move."

Nevertheless, the bus association maintains that they would still welcome dialogue with the government. "We are hoping that between now and when that happens that we at least can go back to the table and sit down with somebody from the government to try and see how we can work something out, because we are very serious about doing this."

Metzgen would not give us an exact date of the BBA's strike action, as he says divulging the date could undermine the effectiveness of their plan of action. However, he did inform that the decision was taken as a last resort and that it had become necessary since their pleas to the

government have fallen on deaf ears.

According to Metzgen, on Tuesday of this week, the BBA met with the Minister of Transport Hon. Rodwell Ferguson and senior officials in the Ministry of Transport to discuss the devastating effects that the consecutive increases in fuel prices have been causing on bus owners. Something which he says the BBA can no longer continue to absorb.

Metzgen said that during the meeting the BBA requested that Ferguson either provided some sort of relief at the pumps for bus owners or approve a 25 per cent increase in bus fares. That request, according to Metzgen,

was met by a flat-out "no" from the Minister who informed them that bus owners cannot increase tariff fares on their own, and neither could he as the Minister, and that it had to go through Cabinet for discussion before it could be approved.

Metzgen said that Ferguson indicated that that would take approximately two weeks before it can be tabled in front of Cabinet.

When we ask him his response to Ferguson's time frame, Metzgen said that the BBA and its members have collectively decided that they simply cannot wait any longer since they have been exercising extreme patience since 2018 when the UDP was in Government. He further indicated that every time there is a meeting between the BBA and transport officials they discuss the same issue, raise the same concerns, and in the end, nothing is done about it.

Metzgen said that, this time, the need for relief for bus operators is critical since apart from still reeling from the economic effects of the pandemic, the price of fuel has seen an increase of 38% in the past couple of months alone, sending bus owners to a "breaking point."

## WHO warns of falsified "Remdesivir" in circulation

The World Health **I** Organization (WHO) has issued an alert to notify of two falsified batches of DESREM "Remdesivir" for Injection 100mg/vial.

Alert, the falsified batches have been identified in Guatemala and India and were reported to WHO in February of this year.

Furthermore, the WHO has confirmed that the laboratory analysis of these falsified products, which the genuine manufacturer conducted, established that "they do not contain any of the stated active pharmaceutical ingredient (remdesivir)."

The analysis goes on to highlight that the physical features of the vials of these "falsified products" may be "smaller than genuine DESREM, and the labels have multiple spelling errors and use the wrong font styles and colors."

Notably, a similar alert was issued in August of 2021 where batches of falsified

to be manufactured by GILEAD. However, GILEAD has since confirmed that the remdesivir products listed in this Alert are falsified and were not manufactured by them.

The WHO closes the report by citing that "Remdesivir is a broadspectrum antiviral medication that has been approved or authorized for emergency use to treat COVID-19 in several countries." Adding that falsified remdesivir products "pose a risk to global public health and hamper efforts to

treat patients with CO-VID-19 and places an additional burden on vulnerable populations and health systems."

before the courts, he explained that the BBA's main contention stems from the way that the new company was brought in.

"We have no problem with competition, but it must be done properly. The way that they were brought in was wrong. They were brought in to piggyback on operators who have been in this industry for years. I mean if you want to bring in someone new then you bring them in to build their runs at a certain time; you don't put them in front of a man that took years to build the runs to where it is now. That is our issue and that is our main contention," explained Metzgen.

While Metzgen had also indicated that the BBA was informed that Floralia Limited was also branching out their service in the north and that they were going to take possession of existing runs from seasoned operators in the north, the Minister of Transport Hon. Rodwell Ferguson told the Reporter that he is not aware of that.

While Ferguson noted that he does not know what will happen in the future, he says that all due process was followed prior to the granting of the Road Service Permits to Floralia.

"We have a very capable transport board and they review every application and determine if it is appropriate or not appropriate. Competition in this country is very fluid and from time to time any new bus that wants to come on the highway has the opportunity to do so because we have a free economy. In Belize, everybody has an opportunity to see how they can participate and provide services to the people of this country.'

In fact, Ferguson

noted that from the very beginning when he took over the Ministry of Transport, he made it no secret that the transport industry was outdated, inadequate, lacked standard, and was in dire need of improvement. That Improvement, according to Ferguson, will not sit well with everybody, but he is prepared for the backlash since it might be the only way that the public transportation system in Belize will get an overhaul.

Barrow and Williams closed off their letter by disclosing that while they have learned that the Department of Transport had approved additional runs for Floralia, which are to commence as early as Monday 14th, March 2022, they were asking the department not to proceed with that implementation. If that should occur prior to the hearing then they say that their clients will take such actions as may be necessary.

# **Belize honors Heroes and Benefactors**

t has been almost 96 years since the late Baron Bliss was buried at sea from his yacht "Sea King" on March 17, 1926, without ever having set foot on Belizean soil. Belize honored its greatest benefactor and two national heroes, the Father of the Nation George Cadle Price, and the founder of the National Independence Party (NIP), Philip Stanley Wilberforce Goldson, with a wreath-laying ceremony in front of the Baron Bliss lighthouse in the Belize City on Monday morning, March 7.

The 4th Baron Bliss of Portugal bequeathed his entire fortune of over a million pound sterling to the fledgling nation of Belize, asking only



that a sailing regatta be held in the harbor in his honor, so the secretary of the Baron Bliss Harbor Regatta Committee, Roberto Pott, read the Baron's memoriam. Born Henry Edward Ernest Victor Barretts in Buckingham County, England, on February 16, 1869, Bliss became a professional engineer, but amassed his vast wealth through shrewd investments, trading in stocks and bonds. When paralysis of his legs confined him to a wheelchair in 1911, he took to the sea in search of adventure aboard his yatch, the "Sea King", and he decided to try fishing Belizean waters in 1926.

He became seriously ill shortly before his 57th birthday, and he executed his will on February 17, 1926 a day after his birthday. His will laid out how his fortune was to be used for Belize's benefit, with the formation of a Trust, with the Governor, the

Colonial Secretary and the Attorney General as its trustees. He died on March 9, 1926, and the Trust helped establish several libraries around the country, the Bliss Nursing School, and many other institutions.

After a thanksgiving prayer service led by Bishop Rev. Lawrence Nicasio, the Governor General H.E. Froyla Tzalam laid a wreath at the Baron's tomb, along with Minister of State Hon. Louis Zabaneh, deputizing for the Prime Minister John Briceño, who is out of the country. Wreaths were also laid before portraits of the National Heroes by their many descendants.

George Price's nephew, Dr. John Waight read his memoriam. The Father of the Nation had humble origins as a schoolboy at Holy Redeemer and St. John's College at Loyola Park, where the 1931 hurricane force him to test his mettle as he swam through the flooded city to somehow reach his home and survive. He studied for the priesthood, but returned to secular life where his rise in local politics led to his true destiny, to form the People's United Party in 1950, of which he became Leader in 1956. He went on to become the Mayor of Belize City, and to be elected to then to the Legislative Assembly from 1954-1961 as First Minister, and to serve as Premier until 1981, when he became Belize's first Prime Minister after Independence until 1984, and for a second term in

1989-93. His diplomatic efforts on the road to independence won him many accolades from the Privy Council in London, from CARICOM, Cuba, Mexico and Venezuela.

Senior research and education officer Rolando Cocom of the National Institute of Culture and History (NICH) read Goldson's memoriam.

Goldson had equally humble origins, joining the Civil Service, then he became a journalist in the 1940's, writing for the Belize Billboard, which was the most prominent newspaper in British Honduras at the time. He eventually became the publisher of the newspaper.

He was also active in the growing labor movement, serving as the General Secretary of the General Workers' union in 1949. He entered local politics, founding the People's Committee, and helping Price to form the PUP in 1950, serving as its Assistant Secretary.

The British colonial masters sentenced Goldson and Leigh Richardson to a year in prison on a charge of sedition in 1951, for their efforts to achieve greater self-governance. Goldson was not discouraged, continuing to write for the newspaper in prison. His articles written on toilet paper, were smuggled out of the prison and published. He also founded the NIP, serving as the only Opposition member in the 18-member Legislative Assembly for many years.

# No busting of sanctions against Russia

The Caribbean cannot escape the economic and financial consequences of the Russian Federation's invasion of the sovereign, independent nation of Ukraine.

The effects of these consequences are already being felt in higher oil prices (at the time of writing, on March 3, the global oil benchmark, rose to \$113.94 a barrel, the highest since June 2014), and they will intensify if the Russian action continues, forcing the world community to show its displeasure through the many sanctions that have been imposed on Russia, not only by countries but also on bodies responsible for international sport.

Rightly, Caribbean countries have participated fully in expressing their disapproval of Russia's infringement of the United Nations Charter, the Charter of the Organization of American States and of international law by its unlawful, unjustified, and unprovoked invasion of Ukraine.

On February 24, all CARICOM states jointly issued a statement, making it clear that "the hostilities against Ukraine go counter to the principles of respect for sovereignty, territorial integrity, noninterference in the internal affairs of another sovereign state and the prohibition on the threat or use of force, and the peaceful resolution of disputes, which are the bedrock of this Community". On February 25, all but four CARICOM countries, joined in co-sponsoring an OAS Declaration by more than two-thirds of its member states, led by Antigua and Barbuda and Guatemala, that "strongly condemn(ed) the unlawful, unjustified, and unprovoked invasion of Ukraine by the Russian Federation and call(ed) for the immediate withdrawal of the military

presence and the cessation of any further military actions in that country".

On that same day, the UN Security Council failed to issue its own condemnatory resolution because Russia, exercised its veto, as one of five permanent members, to stop the resolution. The continued existence of a veto by any one of only five countries is a serious anomaly in today's world. Each of these countries can halt binding UN action against their own violations, crippling the ability to censure them, as is evident from the Russian veto.

After hesitation by some CARICOM countries to participate in the UN General Assembly meeting on Ukraine two days before the invasion, all of them were among the 141 nations at the Special Emergency Session, on March 2, that deplored "in the strongest terms the aggression by the Russian Federation against Ukraine" and demanded "that Russia "immediately, completely and unconditionally withdraw all of its military forces from the territory of Ukraine within its internationally recognized borders".

It is, of course, right that CARICOM countries should adopt a strong position on any country that violates international law by invading other nations, and by seeking to alter the settled borders of countries by force. Within CARICOM. Venezuela threatens Guyana's territorial integrity and Guatemala threatens Belize's. In the case of Guatemala and Belize, they have both agreed to seeking a peaceful settlement through the International Court of Justice (ICJ) and Guatemala has led from the front in condemning Russia's invasion of Ukraine. However, Venezuela has refused to accept the jurisdiction of the

ICJ, and its President is reported to have stated his support for Russia's unlawful actions against Ukraine.

At the meeting of the OAS, where the overwhelming number of countries made a declaration condemning the Russian invasion, I stated on behalf of Antigua and Barbuda the following: "Small and military powerless states depend upon adherence and respect to the agreed and settled principles that are set out in the UN Charter and in international law. When these principles are flouted and international law is violated, small states are obliged to speak out loudly in our own interest as much as in the interest of nations that are the actual victims of aggression".

And, that is the crux of the matter. When international law is breached, the wall that safeguards the interest of small states crumbles, exposing them to the aggression of others; and that aggression can come in many forms, not only military.

In any event, the action of Russia in Ukraine is now so vicious, so inhumane and so alarming that no right-minded society anywhere in the world can do anything but forcefully condemn it. Innocent people, including children and babies, are being killed in their homes as Russia bombards them with long-range missiles in the Russian government's attempt to seize control of their country. Nothing could justify such brutal and cowardly behaviour.

In standing up for an immediate end to the unjustified violence and slaughter in Ukraine, and for the sanctions that have been imposed on Russia, the 141 countries that voted at the UN. and the 25 that voted at the OAS, including all CARICOM states, were also standing up for the protection of themselves from the tyranny of more militarily powerful countries. They were standing up for human values of the right to life and the right to live in peace within secure borders.

In every society, there are those who seek to gain from misfortune and misery. Sadly, there is already some speculation in the Caribbean that governments should allow private companies to profit from busting sanctions against Russia by accommodating, for instance, the yachts of the Russian Oligarchs who have become billionaires through their cosy relationships with the Russian government.

Still others complain about the higher prices that they will have to pay for commodities, such as oil and its related uses. But such persons should be reminded that freedom and the protection of human life and dignity comes by defending what is right and by some sacrifice.

Higher prices will have to be paid for a time, but it is worth the freedom and rights that all humanity deserves. To see the sacrifice for rights and freedom, we need look no further than the courage of the Ukrainian people - men, women and children - who are confronting Russian military tanks and weaponry with nothing in their hands but the flag of their besieged nation.

In the Caribbean, we should remind those, who advocate sanctions-busting for short term gain, of the biblical admonition: "What does it profit a man to gain the whole world and lose his soul".

# How Empowering Women Supports Economic Growth

International Women's Day, first recognized by the United Nations in 1977, grew from early 1900s labor movements for better working conditions and women's right to work. Now, as the continuing pandemic puts female roles in the labor market again in flux, attention to gender has never been more urgent.

IMF research has consistently underscored the benefits of equality, including greater productivity and financial stability. To mark this International Women's Day, we present a roundup of our most recent blogs, podcasts, and research on gender.

Why jobs are plentiful while workers are scarce: Prolonged school closures and scarcity of childcare services put an extra burden on mothers of young children, pushing many to leave the labor force—the socalled "she-cession." A new IMF staff research paper estimates that the excess employment contraction for mothers of children younger than 5 compared with other women actypes of legal barriers to women's economic empowerment, and elaborate on how reforms, such as parental leave can effectively promote gender equality and incentivize women to participate in the workforce.

Unleashing women and girls' human capital: a game changer for Africa: Across most of sub-Saharan Africa, females fall behind males in human capital and related measures. # Lamanai Archeological Reserve Named on 2022 World Monument Watch

The Lamanai Archeological reserve and its surrounding cultural landscape have made it on the 2022 World Monument Watch list, as it is among a selection of 25 world heritage sites that need immediate attention due to pressing challenges.

According to the World Monument Watch list, the various sites were chosen out of a selection of 225 as they were all identified to be among the most at-risk heritage site across the globe, that were facing imminent threats, ranging from economic challenges, climate change, under-representation, imbalanced tourism, and conflict.

According to the official World Monument Watch list site the, Lamanai Archeological Reserve, which is "an international tourist destination encompassing an ancient Maya city requires a more inclusive heritage management plan to help reinforce the relationship between the site and local residents." The site also noted that while the archeological site is home to a wide range of species and wildlife it is also being threatened by agricultural deforestation. Additionally, while the archeological site, like many others around the country, is financed by revenues derived from tourism, it does little to benefit the local community.

The site further notes that the inclusion of Lamanai on the 2022 World Monuments Watch underscores all the above challenges and the need for sustainable tourism management that integrates the local community, ensuring enhanced interpretation of diverse narratives, strengthened protection of the natural environment, and improved local benefit for all.

The Heritage Network in Belize also issued their own press release highlighting the

occurrence and noting that a sustainable future for Lamanai is contingent upon the progressive collaboration and balancing tourism management, natural and cultural protection, and cultural and community quality of life

Sylvia Batty, Director of the Heritage Education Network in Belize also agreed that Lamanai has an intricate story to tell, and the nomination of the site by the group aims to highlight that the site is more than just the ancient Maya site core, but tells the rich history of Belize on a whole and as such needs to be documented and preserved for generations to come.

Batty and her team will be meeting with the caretakers of the site as well as community members to develop a holistic plan that will be rolled out over the next two years.

# **Our Strength is our Unity:** Putin Chose War. We Remain United with Ukraine

This is a dangerous moment for Europe and for freedom-loving people around the world. By launching his brutal assault on the people of Ukraine, Vladimir Putin has also committed an assault on the principles that uphold global peace and democracy. But the people of Ukraine are resilient. They've had a democracy for decades, and their bravery is inspiring the world. The United States, together with our Allies and partners across the globe, will continue to support the Ukrainian people as they defend their country. By choosing to pay for a war instead of investing in the needs of Russians, Putin's invasion of Ukraine will be a strategic failure for the Kremlin and ravage the future of the Russian people. When the history of this era is written, it will show that Putin's choice to launch an unprovoked, unjust, and premeditated attack left the West more unified and Russia exponentially weaker.

#### **United in Our Response**

This will not end well for Vladimir Putin. Together, the United States and our Allies and partners are taking action to hold Russia accountable. As a result of unprecedented global sanctions coordination, the United States, the United Kingdom, the European Union, Japan, and Canada have removed selected Russian banks from the SWIFT messaging system and imposed restrictive measures on the Russian Central Bank. President Biden announced sweeping financial sanctions and stringent export controls that will damage Russia's economy, financial system, and access to cutting-edge technology. After Putin began his invasion, the ruble hit its weakest point in history, and the Russian stock market plunged. Along with the United Kingdom and European Union, the United States imposed sanctions on the architects of this war, including Putin himself.

By moving in close coordination with a powerful coalition of Allies and partners representing more than half of the global economy, we have magnified the impact of our actions to impose maximum costs on Putin and his regime. In response to Putin's war of choice, we will limit Russia's ability to do business in dollars. We will stunt Russia's ability to finance and grow its military. We will impair Russia's ability to compete in the global economy. And we are prepared to do more.

In addition to economic penalties, President Biden authorized an additional \$350 million of security assistance to immediately help Ukraine defend itself, bringing America's total security assistance to Ukraine over the past year to more than \$1 billion. We also stand ready to defend our NATO Allies. Our Allies have also added their own forces and capabilities to ensure our collective defense. There should be no doubt about the readiness of the greatest military Alliance in the history of the world: NATO is more united than ever.

The United States has also coordinated with major oilproducing and -consuming countries to underscore our common interest in securing global energy supplies. We are working with energy companies to surge their capacity to supply energy to the market, particularly as prices increase.

#### Putin's Unprovoked and Premeditated War

This was an attack that Vladimir Putin has planned for a long time. He methodically moved more than 150,000 troops and military equipment to Ukraine's border. He moved blood supplies into position and built field hospitals, demonstrating his intentions all along. He rejected every good-faith effort by the United States and our Allies and partners to address his fabricated security concerns and to avoid needless conflict and human suffering by engaging in diplomacy and dialogue.

Putin executed his playbook exactly as we had warned he would do. We saw Russia's proxies increase their shelling in the Donbas. We saw the Russian government launch cyber-operations against Ukraine. We saw staged political theater in Moscow and heard outlandish and baseless claims made about Ukraine in an attempt to justify Russia's aggression. Russia continues to justify its military aggression by falsely claiming the need to stop "genocide" in Ukraine – despite there being no evidence that genocide was occurring there. We saw Russia use these tactics before when they invaded Ukraine in 2014 and Georgia in 2008.

And then, at almost the very same moment the United Nations Security Council was meeting to stand up for Ukraine's sovereignty and forestall disaster, Putin launched his invasion in violation of international law. Missiles began to rain down, striking historic cities across Ukraine. Then came air raids, columns of tanks, and battalions of troops, all riding a renewed wave of disinformation and outright lies.

We have been transparent with the world. We declassified our intelligence about Russia's plans so there could be no confusion and no cover up. Putin is the aggressor. Putin chose this war. And now his people will bear the consequences of his decision to invest in war rather than in them.

## Transatlantic Unity and Resolve Stronger Than Ever

Putin's goal of dividing the West has failed. In the face one of the most significant challenges to European security and democratic ideals since World War II, the United States and our Allies and partners have joined together in solidarity. We have united, coordinating intensively to engage as one with Russia and Ukraine, provide assistance to Ukraine, develop a broad and massive response, and reaffirm our commitment to

erek Zenon Paul Saldivar was born June 4, 1959 in Belize, Central America (which was then British Honduras). He was the second son of Philip and Marie Saldivar, and the fourth child of nine children. Derek attended Grace Primary School where he excelled in the arts, winning prizes at the national Festival of Arts for the best play and best actor which set the stage for much of his later pursuits in life. He and his older brother David, became well known in local events for their stage appearances particularly in Bob Reneau's well known plays, Breggin Tuba (Derek was the peanut boy) and was greatly missed when after a few years at St. John's Junior College, the family emigrated to

the United States of America.

There was an adjustment to a different culture, but Derek wasted no time after getting accepted to Evander Child's High School, to make a name for himself as an arts major. He won a **Regents Scholarship** and went on to City University of New York for two years. Then the family faced a huge challenge when a fire broke out in the home. Derek was devastated when as he lost his precious collection of artwork which he had been preparing for an exhibition. The family had to find a new residence and Derek's dreams were shattered and uprooted. For a while Derek worked at different jobs, as he felt an obligation to help the family. Finally he went off on his own and joined the navy. He adapted himself to military training and endeared himself to his colleagues with his jovial manner. When his time came to an end, Derek finally renewed life in his homeland. He started having medical challenges but that did not knock him down.

## Health Minister: 'Belizeans taking things for granted' Authorities concerned over drunken brawls, mass gathering over the weekend

t might have I only been a trial period to gauge the reaction of the public for the first weekend since the curfew and mask mandate was lifted, but the events of the extended holiday weekend which saw multiple parties, mass gatherings, and even drunken brawls among women, have been a major cause of concern for officials.

The Minister of Health Hon. Kevin Bernard, who had been monitoring the behavior of the public over the weekend, said that he was not satisfied with what he saw and was equally as disappointed in the actions of the Belizean people. In fact, Bernard said that he is keeping his fingers crossed and is hoping that the events of the weekend do not spiral out of control and create additional problems

for the health system. Bernard told our newsroom, "I think that Belizeans take things for granted. They need to understand that the virus is atill here and we need

stand that the virus is still here and we need to protect ourselves and others around us. I believe that while we agreed that we needed to open up a bit, ease off some of the restrictions, these were done with the hope that Belizeans would still be able to abide by the rules. ... I saw images of people gathering in huge numbers, no mask being worn, and while I agree that they were outdoors, I think that if you are self-conscious you would know that if you are in a crowd you are to wear your events of the weekend also confirmed that there were multiple brawls in Belize City and Burrell Boom which stemmed from the La Ruta Maya race. Williams reminded the public that in the majority of instances those individuals were not wearing their masks and as such posed a threat to the health of the officers who had to intervene in the situation.

"I want to appeal to people: celebrate, enjoy yourselves, but for Christ's sake, let us act like civilized people. We cannot be enjoying ourselves and be fighting with each other because it's no longer enjoyable. Some people are operating seemingly with no regard to the fact that we are still in a pandemic. While yes, it is clearly the intention of the government to relax the measures, at the same time we still need to act responsibly, either individually or collectively," reiterated the Commissioner.

Williams also noted an increase in the number of restaurants that are now operating as nightclubs and bars, as well as persons who are not abiding by the indoor mask mandate for being in a crowd, or while inside any shops, offices, and restaurants. Williams said that he have instructed his officers to be on the lookout for these occurrences and take actions against the owners, either under the CO-VID regulations or under the intoxicating liquor license act.

Williams said that the police will also be out monitoring mass gatherings and events such as those that managed to slip through over the weekend. The Police Department will continue to work along with the Ministry of Health, event organizers, restaurant owners, and the public to ensure that they abide by the different protocols that are still in place.

have a voice in the decision-making in every aspect of life, Lavalle—the event's guest speaker declared, and no longer will women be content to accept that their place is in the kitchen and looking after their children at home. The need for change is most urgent in Mexico and the rest of Latin America. Even as she spoke, she noted that there were mass demonstrations happening throughout Mexico, which is experiencing a crisis of violence against women, which mostly goes unpunished, she lamented.

Belize stood out in the entire region for the number of women elected to local government in the 2018 Municipal Elections, Lavalle noted, when women won 17 of the 67 seats, and gained more ground in 2021 Municipal Elections, when 22 women were elected.

In the 2020 General Elections, women won barely 10 percent in the House of Representatives, when only three women were elected of 13 women on the ballot. In this, Belize lags far behind Cuba and Nicaragua that have 40 percent women participating in government, the regional average in Latin America is 30 percent.

Barbados and Suriname stand out with a surprising 70 per cent woman in the seats of government. Jamaica, Cuba and Guyana have 60 percent women in elected office. Among Cabinet ministers, only Nicaragua, Costa Rica and Colombia have parity, with an equal number of women and men as government ministers. In the other 27 countries of Latin America, women do not reach even 30 percent. Cuba, Nicaragua, Costa Rica, Mexico and Suriname are the countries who are consistently in the top 10 in achieving advances in women's rights, the rest of the region lags behind.

Mexican women have achieved more through quotas, as all political parties are required to have a minimum of 30 percent women on the ballot. These achievements have come through much blood sweat and tears, and much more needs to be done. Time is of the essence, for at the present rate of advancement, it would take women at least another century to achieve parity, Lavalle cited.

# 'Ganja' Bill to be introduced in the House

C abinet gave its recommendation for the introduction of the "Cannabis Control and Licensing Bill 2022" at the next sitting of the House of Representatives, the government announced via this week's Cabinet brief.

"The adoption of the Cannabis Control Bill will provide for the control and licensing of the Cannabis industry and to establish the necessary legislative framework to govern and regulate the cultivation, processing, distribution, and delivery of Cannabis products for adult use only," the brief explained.


While the opening up of the Cannabis industry is highly anticipated by supporters, financial sector stakeholders have expressed a degree of disquiet. Recently, The Reporter interviewed the former Central Bank Governor Mr. Glen Ysaguirre and Heritage Bank's Managing Director Mr. Steven Duncan, who both questioned whether the industry would be able to utilize local banks.

"The challenge I can see that local banks may encounter is restrictions from their correspondent banks to do business with people who are in the cannabis international correspondent banks run the risk incurring charges of aiding and abetting a federal crime or money laundering.

"I'm not sure what type of assurances [if any] the ministry would be able to give the correspondent banks as the Government of Belize cannot indemnify any correspondent bank of federal violation in their jurisdiction," he opined. "If the Federal Reserve or federal regulators haven't given permission to bank people in the cannabis industry [within the US], I don't see them making an exemption for Belize."

For his part, Managing Director of Heritage Bank Steven Duncan also highlighted just about six years ago local banks lost numerous correspondent banking relationships, all of which came without any direct justification. Since then, the sector has been "chasing ghosts" to ensure that whatever it is that they did wrong is corrected.

Duncan also pointed out that Belize cannot utilize non-USA banks. "Two of the three private-sector banks in Belize use the same bank as correspondent bank out of the United Kingdom. Because the US is our country's largest trading partner, that bank in the UK must have relations with an American clearing bank to complete transactions. They cannot complete it on their own.' Given the risks of de-risking, industry experts suggest that it is very likely dispensary proprietors would have to operate a cashonly business and lose crucial access to banking services such as lending opportunities, payroll, checking, and credit accounts, among other benefits.

SIB does not have any statistics on the number of undocumented migrants in Belize. Therefore, accurate projections of social assistance, losses in tax revenue, increasing social impacts, and unbalanced access to social services are "impossible."

While some of the migrants have, since 2010, regularized their status, it is believed that many more have entered the country and have irregular immigration status. Therefore, following data highlighted by the Ministry "using the figures from the two amnesties and the estimate in 2010, the Ministry of Immigration estimates that the number of irregular migrants in Belize in 2021 would be approximately 40,000-60,000 migrants."

BWRC works closely with the Forest Department in responding to wildlife issues, providing the necessary medical care and rehabilitation. In the past, BWRC has provided basic animal health check-ups for the captive wildlife. # Aptus Pi creates Digital Classroom without walls

eachers now have a new tool to create a digital "classroom without walls', through the innovative Aptus Pi microcomputer that the Ministry of Education, Culture, Science and Technology (MoECST) introduced in 15 schools around the country in partnership with the Commonwealth of Learning and Notes Master

Minister of Education Hon. Francis Fonseca said the new devices were "exciting and one with great potential", when he presented them to the schools representatives at the launch of the pilot project at the Gwen Lizarraga High School in Belize City last Wednesday, March 3. He said they would minimize the digital divide which was exacerbated by the CO-VID-19 pandemic

As the Ministry's ICT manager Ismael Noble explained, the devices do not require internet access to provide access to learning resources, as teachers can use the device to create a local WiFi network, which all their students may access from their cellphone, tablet or laptop computer. This allows them to set up a virtual classroom in a remote rural village or a vast university campus. The device can contain all the learning materials as electronic documents in its 64 gigabytes of storage memory, which the teacher can then share with the students by WiFi.

The Aptus-Pi device has a rechargeable battery which can be recharged from the BEL grid power or from solar charger. It operates on only 15 watts of power, which is less than a fluorescent light bulb, and allows the teacher to conduct a lesson even in areas which have no power from the BEL grid, as long as the students' devices are charged. The students can turn in

assignments via WiFi, and the teacher can return corrected homework and tests, and communicate with all the students, without Internet access. The teacher can also up-

In the Cayo district, Mopan Technical High School and the evening divisions of the Belmopan Adult Education Programme and St. Ignatius High. Down South, Independence High School and Julian Cho Technical are in, along with the evening divisions of Ecumenical High and St. Peter Claver Extension.

# A third person has been cured of HIV, scientists report

A woman became the third person ever to be cured of HIV, the virus that causes AIDS, after she received a stem-cell transplant that used cells from umbilical cord blood, scientists reported Tuesday (Feb. 15).

The two other people cured of HIV, Timothy Brown and Adam Castillejo, both received bone marrow transplants from donors who carried a genetic mutation that blocks HIV infection, Live Science previously reported. These transplants contained adult hematopoietic stem cells, which are

stem cells that develop into all types of blood cells, including white blood cells, a key component of the immune system.


This genetic mutation is rare and has been identified in only about 20,000 bone marrow donors to date, The New York Times reported. The bone marrow transplant procedure itself takes a heavy toll on the body, both during the highly invasive procedure and for some time afterward. In both Brown and Castillejo, immune cells from the donors' bone marrow launched an attack against cells in the patients' bodies; this condition is known as "graft versus host disease." Following this initial reaction, though, both men were cured of HIV.

She left the hospital just 17 days

after her procedure, without any signs of graft versus host disease, Dr. JingMei Hsu, the patient's physician at Weill Cornell Medicine in New York, told the Times. Her case dispels an existing theory that triggering graft versus host disease might be a necessary step in curing someone of HIV, Dr. Sharon Lewin, president-elect of the International AIDS Society, who was not involved in the work, told the Times.

In addition to being HIV-positive, the woman had acute myeloid leukemia, a cancer that affects blood-forming cells in the bone marrow, Reuters reported. She had received the umbilical cord blood as both a treatment for the cancer and for her HIV, as her doctors identified a donor with the HIVblocking genetic mutation. Cord blood contains a high quantity of hematopoietic stem cells; the blood is collected at the time of a baby's birth and then donated by the parents, according to the Memorial Sloan Kettering (MSK) Cancer Center.

Cord blood offers an advantage over bone marrow because donors don't need to be closely "matched" to their transplant recipient, according to MSK. For bone marrow transplants, doctors check the donor's and recipient's human leukocyte antigen (HLA)



tissue type, which refers to whether the individuals carry specific proteins, called HLAs, in the tissues of their bodies. HLAs come in different flavors, and these flavors must be closely matched between a bone marrow donor and a recipient to avoid a catastrophic immune reaction.

But because a baby's immune system is still quite immature at the time of birth, the HLAs of the baby and cord blood recipient don't have to match as closely as the HLAs of a bone marrow donor and recipient, MSK notes. The baby's immature cells adapt to the recipient's body more easily than adult cells. In the woman's case, her donor was "partially matched," and she also received stem cells from a close relative to help bolster her immune system after the transplant procedure, the Times reported.

"The transplant from the relative is like a bridge that got her through to the point of the cord blood being able to take over," Dr. Marshall Glesby, an infectious-diseases expert at Weill Cornell Medicine and part of the research team, told the Times.

The woman's procedure took place in August 2017, according to The Guardian. She elected to stop taking antiretroviral drugs, the standard treatment for HIV, 37 months after her transplant,

the Times reported. More than 14 months have passed since then, and still, no trace of the virus or antibodies against the virus can be found in her blood, the Times reported.

The woman's case is part of a larger U.S.-based study that will follow a total of 25 people with HIV, Reuters reported. These individuals will undergo an umbilical cord stem-cell transplant for the treatment of cancer, and the trial organizers will then monitor them to see whether their HIV status changes following the procedure. In general, umbilical cord blood is more widely available and more easily matched to recipients than bone marrow. So some scientists think the procedure may be

more accessible than bone marrow transplants to HIV patients.

"We estimate that there are approximately 50 patients per year in the U.S. who could benefit from this procedure," Dr. Koen van Besien, director of the stem cell transplant program at Weill Cornell Medicine and one of the doctors involved in the treatment, told The Guardian. Worldwide, nearly 38 million people are living with HIV, according to the Times.

"The ability to use partially matched umbilical cord blood grafts greatly increases the likelihood of finding suitable donors for such patients," van Besien said.

# **FUN FACTS!** Did you know your skin sheds?

Skin is our largest organ—adults carry some 8 pounds (3.6 kilograms) and 22 square feet (2 square meters) of it. This fleshy covering does a lot more than make us look presentable.

According to a 2011 study published in the journal Environmental Science & Technology, we shed between 0.03 and 0.09g of skin every hour. That sounds like almost nothing, but over the course of a lifetime it adds up to about 35kg, or roughly half your bodyweight. Most of this is in the form of tiny flakes, which make up a major constituent of house dust.

Interestingly, the same study found that the squalene oil on shed skin reacts with harmful ozone in houses, offices and aeroplanes, so dust can actually improve the air quality.

Your skin undergoes a natural turnover cycle every 30 days or so. When this happens, the upper layer of your skin (epidermis) sheds, revealing new skin from the middle layer of your skin (dermis). However, the cell turnover cycle



isn't always so clear-cut. Every hour we shed approximately 1,500,000 dead skin flakes. An average night of sleep can yield over 12,000,000 dead skin flakes, and it all ends up in YOUR MATTRESS EACH DAY!

Peeling is the body's way of repairing damaged cells. Peeling skin is harmless and helps the healing process, but it can be itchy and uncomfortable. Peeling skin is a common problem after a sunburn.

Scientists have previously known the epidermis consists of a thick outer barrier of dead epidermal cells, which are constantly shedding. What they've known less about is a secondary barrier deeper below the surface in the epidermis that is made up of only a single layer of cells, which forms a much thinner, though no less important, protective barrier.

Now, a team from Keio University in Japan, working with a researcher at Imperial College London, have discovered that the shape of the epidermal cells is actually a flattened version of a tetrakaidecahedron - a 14-sided 3D solid made out of six rectangular and eight hexagonal sides.

The team says the epidermal cells' shape means that it can always form a tight, cohesive bond with the epidermal cells surrounding it. The team also discovered that these cells manufacture proteins, which act as a temporary glue that binds the cells together in what are called 'tight junctions', which are depicted in the video. The combination of the cells' geometry and tight junction formation means that the skin barrier can maintain its integrity even though it is very thin.

When new cells undemeath form the new tight junctions, this pushes the older cells upwards towards the surface of the skin, and the older cells lose their tight junctions. In this way, the tight junction barrier in the cell sheet is always maintained.



# The Righters Write Women and Climate Change

The month of March is observed as women's month. It's a time when the call for the protection of women's and girls' rights and equality are amplified in many countries, a call to #BreakTheBias.

This year, there is special attention being placed on the close link between gender, social equity and climate change. In this column we have looked closely at human rights and its close corelation to climate change. Climate change, as we had stated then, is a direct threat to human rights and the enjoyment of human rights. Without our natural resources, humanity will face famines, natural disasters, mass migration and much more. Life as we know


it would drastically change, more so for some than for others.

On International Women's Day, March 8, women and their supporters joined in the call for climate action for women by women under the theme "Gender equality today for a sustainable tomorrow". The UN reports that "without gender equality today, a sustainable future, an equal future, remains out of reach". And this has come as a result of new developments. So why make women and girls a focus of the efforts to mitigate and adaptation to climate? Currently, women and girls face many gender inequalities. If you add climate change to that, they stand to face some of the greatest impacts of the climate

crisis as it amplifies these inequalities placing their lives and livelihoods at risk. The UN reports that "across the world, women depend more on, yet have less access to, natural resources, and often bear a disproportionate responsibility for securing food, water, and fuel."

It adds too that "As women and girls bear the burden of climate impacts, they are also essential to leading and driving change in climate adaption, mitigation and solutions. Without the inclusion of half of the world's population, it is unlikely that solutions for a sustainable planet and a gender equal world tomorrow will be realized."

UN Women adds that "Gender inequality coupled with the



the greatest challenges of our time. It poses threats to ways of life, livelihoods, health, safety and security for women and girls around the world." UN Women takes a closer look at how climate change impacts women and girls. "In many regions, women bear a disproportionate responsibility for securing food, water, and fuel. Agriculture is the most important employment sector for women in low- and lower-middle income countries, during periods of drought and erratic rainfall, women, as agricultural workers and primary procurers, work harder to secure income and resources for their families. This puts added pressure on girls, who often have to leave school to help their mothers manage the increased burden. Climate change is a "threat multiplier", meaning it escalates social, political and economic tensions in fragile and conflictaffected settings. As climate change drives conflict across the world, women and girls face increased vulnerabilities to all forms of gender-based violence, including conflict-related sexual violence, human trafficking, child marriage, and other

climate crisis is one of

forms of violence." It goes on to add that "When disasters strike, women are less likely to survive and more likely to be injured due to long standing gender inequalities that have created disparities in information, mobility, decision-making, and access to resources and training. In the aftermath, women and girls are less able to access relief and assistance, further threatening their livelihoods, wellbeing and recovery, and creating a vicious cycle of vulnerability to future disasters. Women's and girls' health is endangered by climate change and disasters by limiting access to services and

health care, as well as increasing risks related to maternal and child health. Research indicates that extreme heat increases incidence of stillbirth, and climate change is increasing the spread of vectorborne illnesses such as malaria, dengue fever, and Zika virus, which are linked to worse maternal and neonatal outcomes."

Here in Belize, the National Climate Change Office has recognized the importance of human rights in its approach towards mitigation and adaptation efforts. For them, a key part of the response is the strengthening of community resilience, or in other words, working more closely with the community. Lennox Gladden, the chief climate change officer at the National Climate Change Office, told the Human Rights Commission of Belize in an interview that "during the past couple years, we've taken a different approach towards building resiliency especially as it relates to the impact of climate change. As an office we realize that climate change isn't only an environmental issue, and we also take into consideration that – we have to take into consideration - the economics of climate change and also the social. Under the social. of course, we identify that some of the more major impacts of climate change affects livelihoods. So, this in part looks at how it trickles down to human rights. So, we do identify the importance of that linkage and how important it is to actually have a people centric approach when building some level of resiliency or trying to adapt or mitigate some of the impacts of climate change." The new approach is including a series of stakeholders that encompass organizations and government departments that work

with different sectors of the community. The approach may very well be the best. According to the UN, "Women and men in rural areas in developing countries are especially vulnerable when they are highly dependent on local natural resources for their livelihood. Those charged with the responsibility to secure water, food and fuel for cooking and heating face the greatest challenges. Secondly, when coupled with unequal access to resources and to decision-making processes, limited mobility places women in rural areas in a position where they are disproportionately affected by climate change. It is thus important to identify gender-sensitive strategies to respond to the environmental and humanitarian crises caused by climate change."

It is important to take into account the way in which gender equality and climate change are closely related but equally important is to consider what role women can play in the mitigation and adaptation efforts to climate change. The UN adds that "Women often have a strong body of knowledge and expertise that can be used in climate change mitigation, disaster reduction and adaptation strategies. Furthermore, women's responsibilities in households and communities, as stewards of natural and household resources, positions them well to contribute to livelihood strategies adapted to changing environmental realities." A<sup>11</sup> older Belizeans know that only our politicians possess the power and potential to solve our gang problem. Both our politicians and our policemen presided over the birth and development of our gang culture. They are the only ones with the power and authority to initiate meaningful measures to root it out of our nation.

It is a historical fact that during our colonial past not a single life was lost in our country by reason of gang violence. And, not a single Belizean was found to be associated with drug trafficking. The Government of Belize (GOB) has received financing from the Inter-American Development Bank (IDB) for the execution of a five-year tax modernization project entitled "Strengthening of Tax Administration" (BL-L1031). Through this project, the Belize Tax Service Department (BTSD) has procured a Modern Integrated Tax Administration System (the Revenue Management System (RMS) and is presently in the implementation process. This new system will be used in the management of the Belize Tax Administration.

The BTSD Strategic Plan clearly addresses the relevance of taxpayer segmentation and the risk management approach. It indicates that:

"It has become good practice for Tax Administrators across the world to implement Taxpayer Segmentation in revenue management to effectively analyze taxpayer data and to efficaciously implement different and specific surveillance and control mechanisms," and that; "The deployment of a 'Risk management approach' is a modern and pertinent tactic that would aid in compliance. This approach gives a structured basis for strategic planning; focuses on the underlying drivers (not symptoms) of non-compliance; promotes diversity in the way major tax compliance risks are treated, rather than a 'one size fits all' approach; realizes better outcomes as it refers to efficiency and effectiveness of programs; coincides with international standards and is a strong basis for evidencebased evaluation.

Consequently, the BTSD will explore the introduction of a Risk Management Plan (RMP) to properly respond to the risks identified on a timely basis, to minimize overall compliance burden for both the taxpayers and the tax administration. As an important aspect of the RMP, risk mitigating strategies will be proposed for application against potential and existing risks. The plan will highlight all areas of risks including risk-based assessments, risk-based audits, risk-based sector and taxpayer segmentation, compliance risks (registration, filing, reporting and payments) and international risks. Risk mitigation reduces the extent of exposure and ensures that the strategic objectives are achieved."

The consulting services (**"the services"**) includes the contracting of a Consultancy Firm for a period of five (5) months to review and update the current Taxpayer Segmentation and develop a Risk-based compliance management model, including configuration of the model in the ITAS.
