While Armando Cowo, manager of the Belize Poultry Association, could not tell us the duration of this latest increase, due to the fluid situation as it relates to the everchanging price of fuel around the world, he says that the association is not foreseeing any additional increase in the next couple of months. Cowo is also estimating that if the war in Ukraine ends soon as is being anticipated, then the local economy and even fuel prices will revert back to normal by May of next year.

Cowo explained to our newsroom, "prices will go up, we are currently rolling out a price adjustment, these changes as we all know is due to several factors and not just one. Fuel is one of them but our

went on to list the new prices and was signed by Castillos Bus Line and Perez Transport.

When we got in contact with BBA's Secretary Ewart Metzgen, to inquire about whether these bus companies have been jumping the gun he indicated, "We at the BBA have asked our member's not to apply new prices as they don't know what those prices will be. Those that we know who are increasing prices are not members of the BBA. Yes, they are going against the law because bus fares are regulated by the government. We waited for over thirty years for this. What's a couple of days more?"

Metzgen additionally noted that while they had gotten positive feedback from the Prime Minister last week about a possible price increase that has still not been endorsed since it has to be tabled by Cabinet before it can be approved and rolled out. Metzgen was still unable to say how much the increase will be but noted that it will be implemented on April 15th, 2022, so as means of giving the

public ample time to prepare.

We also reached out to the BBA President Thomas Shaw for comment on the situation and he told us that he has already reached out to the bus companies who have implemented the increase and instructed them to "hold off on doing so" until they are furnished with the valid price struc-

industry is very energy-intensive we consume a lot of energy in different forms and in different stages of the processing stages. We consume a lot of diesel for our trucks, we also buy a lot of our corn, and soybeans from the grain industry here in Belize, and that price is being passed on to us. We also have the situation of the fluctuating prices on

the world market in regards to fuel. Currently, it is well over 100\$ for a barrel, two weeks ago it was at \$139 US a barrel for oil. All of this has a huge impact on the industry."

Cowo also referred to the increased price for plastic that the various processing plant utilizes to ensure utmost food safety. He also claimed that there has been an increase in the price of fertilizers, all of which are considered to be petroleumbased products.

Despite the increase on their end, Cowo is warning food vendors to refrain from engaging in price gouging. He noted, "It's going up cents per pound, I don't see why food vendors would want to add a dollar to it. I mean if the people in the food business want to raise their prices, let them do so and justify it but don't do that solely on using the price adjustment from the industry, because we are just doing it by cents. They are not even paying 25 cents and for them to be charging an extra dollar for a plate of food when they are not giving consumers a lbs of chicken on the plate."

Cowo is asking consumers to be vigilant and to report any price gouging to the Association or the Belize Bureau of Standards.

Smith explained that it was designed to reduce crime by partnering with the community, the media and the local police, and other law enforcement agencies. This is done through the media reporting the crime, the community identifying the criminal and passing on that information to CSB.

Smith said that back

not been easy because we have a tendency for natural mistrust of the system and the Police Department. We would usually receive about 40 to 60 tips a month. Sometimes like if there is a lot of things that is happening we receive more tips. If things are quiet the tips drop down to sometimes 10 tips for the month. It not like a huge amount but it is a steady flow."

how the program works, she explained to us that persons can call the toll free line at 922 or even submit an online tip. The call is answered by international operators, who takes the information and pass it on to the relevant authorities. Each caller is given a code number so that their identity can remain unknown. They are instructed to call back to check on the outcome of their tip. If the information result in an arrest and charge then the caller is eligable for a cash reward. "Its more like a tip, its

not like an entire supply of evidence. Unless its a picture showing that person committing the crime or something like that. its normally a guide to send the investigators in that direcrion and then the investigators take it fom there," explained Smith.

She also added that CSB would usually follow up with the relevant authorities to get an update on the case. That is then used as part of the CSB statisticts. The program is funded through corporate sponsors, donations and fund raising.

The trouble with Indian Creek is that the village has run out of land for growth and expansion. when the project was launch there were between 8 to 10 murders a year, but that the pattern had warned of an expected increase over the years. It was therefore agreed that a program such as CSB was needed to provide a venue by which Belizeans could have the opportunity to report crime without the fear of being targetted, either by the criminals or even law enforcement authorities.

19 years later CSB has been dubbed a success and has aided in solving crimes, getting firearms and drugs from off of the street, and even making payouts to successfull tips, that have resulted in arrest. Smith indicated, "Its

aim of the program was to provide witness with incentive such as cash payouts for any tips that lead to an arrest or the seizure of firearms and drugs from off the street, Smith said that the most intresting part about that is that majority of the callers are not intrested in payouts. Rather they are more interested in seeing justice being served. She noted that while there have been payouts in the past she classified them as being "very minimal" and not even worthy of mentioing.

"What is important is that the criminals are not allowed to roam free without justice, " she said.

over the Dutchess shimmering pink metallic gown and her husband's jaw-dropping speech to the gathering completely stole the show.






# Personal Income Tax Has Untapped Potential in Poorer Countries

#### **Steady rise**

Personal income tax revenue has been increasing in low-income and emerging market economies in recent decades. (personal income tax revenue, percent of GDP)



also extends to other taxes. Moreover, the accelerated shift into digitalized services because of the pandemic can pave the way for better income tax design and enforcement.

What about the redistributive impact of the income tax in developing countries? To explore this, we separate the effects of policy design from the size of the population covered by the tax. Interestingly, the design of this tax in low-income countries is typically progressive; it is instead the narrow coverage that makes the overall contribution to redistribution very small compared to that seen in advanced economies. In emerging markets, however, it's not progressive. It would seem, then, that there is significant potential to improve inclusion in this latter group of countries (several of which have a flat income tax).

Is there scope to increase personal income tax revenue in the postpandemic recovery?

To answer this question, we look at how additional revenue is raised from alternative sources. Here again, there is a large difference between advanced economies, where additional revenue is predominantly sourced from the income tax, and lowincome countries, where it plays a much more modest role. Other taxes will likely have to play a significant role, therefore, in raising revenue over the medium term, with the value-added tax and other indirect taxes remaining the main contributors.

But income taxes can still be important for inclusive growth if properly designed and revenues well spent. Our research—together with the history of the tax in advanced economies shows that the personal income tax should evolve into a more significant source of revenue as countries develop.

Many govern-ments aiming to achieve a durable economic recovery from the pandemic must raise significant amounts of revenue in the fairest way possible. The personal income tax-levied on wages, salaries, and other income—is a suitable instrument for this challenge. In new research, we examine the scope for making greater use of this fiscal tool in developing countries, where many people earn a living at low

incomes. Still in its infancy, but to lessen inequality.

But gradual changes have been taking place. In the two decades preceding the pandemic, income tax revenue more than doubled in low-income countries, rising from the equivalent of 1 percent of GDP to 2.1 percent, while emerging markets saw an increase from 2.1 percent to 3.1 percent. These were also reflected in share of the tax in overall tax intake, which went from 5 percent to 8 percent of total tax revenue in lowincome countries and from 9 percent to 11 percent in emerging markets. Our research on this progress focuses on three questions: what drives personal income tax growth, how increases affect total revenue performance, and how these levies influence income redistribution. Our findings hold important lessons for developing countries, particularly as they grapple with the post-pandemic challenge of building the capacity to raise more tax revenue. What drives revenue growth? In examining the progress of the personal income tax in developing countries, we distinguish between observable tax policy changes and broader economic

changes. Policy changes have targeted top and bottom statutory rates as well as the level of exempt income. Remarkably, we find that this hasn't contributed much to the increase in revenue in low-income countries.

And in emerging market economies, this shift has sometimes actually reduced revenue. This is the case in part because many emerging markets have introduced flat tax systems with low rates and those with progressive schedules have reduced rates over the last

growing

The personal income tax had become the predominant tax by the eve of World War II in many advanced economies, where it now raises approximately 9 percent of gross domestic product. In addition to bringing in revenue, it is progressive—imposing steeper rates on those with a higher income—and reduces inequality measurably.

In most emerging market and low-income countries, on the other hand, such taxes are still in their infancy. Revenue from this source averages only 2.5 percent of GDP in these countries, in part because of their narrow tax base, and it does little two decades.

Economic variables, on the other hand, played a very important role. We looked at increases in per capita incomes and the size of the publicsector wage bill and the reduction in the size of the informal sector, as measured by the share of self-employed workers in the labor force and the share of agriculture in the economy. These developments have clearly been the driving force behind the growth in personal income tax revenues. As economies develop, we can expect this tax to take on greater importance.

Improvements in tax administration also potentially play a role in boosting revenues, though that

# **Fuel Price Update**

#### Belmopan. March 24th, 2022. 2:00 p.m.

The Ministry of Finance announces that effective today, March 24, 2022, the regulated pump price of regular gasoline is now prescribed at \$13.50, representing an increase of 66 cents compared to the last shipment Belize received.

Not only is this increase entirely attributable to the acquisition costs of the product but in order for the price to be kept at this level, the Government reduced all levies on regular fuel by 29 cents.

As Hon. John Briceño, Prime Minister and Minister of Finance,

process of establishing a Fuel Stabilization Mechanism which is expected to provide some level of price predictability while protecting fiscal targets in the national budget.

The ministry is also actively engaged with various stakeholders in the pursuit of certain burden sharing initiatives that can contribute to price stabilization, and eventually, price reduction. In this regard, the Government has been emphatic with Belize's principal fuel importer, Puma Belize Ltd., about the imperative of competitive acquisition and pricing.

Countries over the world are enduring fuel price surges as a direct consequence of Russia's invasion of Ukraine. Though future prices are impossible to predict, the Government of Belize continues to examine all viable policy options for minimizing the fuel price shock, balancing as best as possible between the twin demands of affordable pump prices and budgetary steadiness.

# **GOB begins Coastal Marine Project Finance initiative**

The Government will begin the design of a Coastal and Marine Project Finance for Permanence (PFP) initiative, Prime Minister Hon. John Briceño, announced Thursday morning, March 24.

The project follows up on a Memorandum of Understanding which the Government of Belize officially signed with World Wildlife Fund (WWF) and The Nature Conservancy (TNC) at the Conference of Parties (COP26) on the United Nations' Framework Convention on Climate Change (UNFCCC) in Edinburgh last year.

The initiative will help Belize to secure long-lasting protection of its unique and globally significant biodiversity, foster long-term economic viability and sustainable livelihoods, and strengthen the resilience of coastal communities to the impacts of climate change.

A Project will enable sustainable financing for Belize's marine protected areas and broader coastal ecosystems over the long term, and is a key part of ensuring the effective management of Belize's marine resources. The project borrows from private sector practices for organizing and financing complex, resource-intensive, and well-defined projects. The initiative aims to address the issue of insufficient funding for the management of conservation areas.

"Belize's marine and coastal natural assets are central to its national development and economic recovery, while meeting

embers of Cabinet attended a cattle export ceremony at Cacabix corral in Shipyard, Orange Walk District, which saw the establishment of a formal trade agreement between Belizean livestock farmers and SuKarne, a Mexican meat company.

Opening the ceremony was keynote speaker Minister of Agriculture Hon. Jose Abelardo Mai, "Today, we exported 266 heads of cattle to Mexico. Those will leave the border today en route to Michoacán. I am told that our animals first

In addition, we must livestock will require recurring capital investments of up to BZ\$3,000,000, almost monthly, before profits are realized.

According to the Government, based on final evaluations, E-kyash was selected as the first electronic payment solution to pilot online payment for processing Temporary Work Permit applications within the Labour Department's Temporary Employment Permit system.

Rodriguez claimed that that shouldn't have happened, rather that his clients should have been given the opportunity to justify their absence to the magistrate who would, in turn, consider whether or not to remove the bench warrant.

The Meighan brothers, who are wellknown gang members, are believed to be part of a larger exodus of alleged gang members who are fleeing Belize City to the United States in search of a better life.

# Jamaicans sing "Reparation Song" as Royals continue their Caribbean Tour

"We, therefore, will not participate in your Platinum Jubilee celebration!" these were sentiments shared by the Jamaicabased Advocates Network (Advocates) in an open letter to Prince William and the Duchess of Cambridge on the eve of the Royals arrival to Jamaica.

The letter, penned on behalf of a group of Jamaican business leaders, doctors, and politicians, opens by lamenting on the implications current world crises have already imposed onto their country, "We note with great concern your visit to our country Jamaica, during a period when we are still in the throes of a global pandemic and bracing for the full impact of

of Jamaica's Independence.

"We see no reason to celebrate 70 years of the ascension of your grandmother to the British throne because her leadership, and that of her predecessors, have perpetuated the greatest human rights tragedy in the history of humankind." Said the Advocates.

They continued by declaring, "We will not participate in your Platinum Jubilee celebration! ... We will, however, celebrate 60 years of freedom from British colonial domination."

Towards the end of the letter, the Advocates urged the Royals to reflect thoroughly on "these 60 reasons you should apologize and begin a process of reparatory justice."

Of the "60 reasons" for reparation in enslaved people"; and "For causing the high mortality on the floating dungeons you called 'slave ships' because of the inhumane conditions on board,' to cite a few.

Notably, a portion of the Royals' tour throughout rural Belize met much opposition from locals. This led to them being forced to cancel their visit to Akte'il Ha cacao farm in Indian Creek village in the foothills of the Maya Mountains, as there is a dispute between village residents and Flora and Fauna International (FFI), a conservation charity William supports as patron.

Similarly, as penned in the open letter to the Prince and Duchess, the Advocate Network plans to stage a demonstration outside the Jamaican British High Commission when the royal couple arrives in the country.



# UN: "We are sleepwalking to climate catastrophe"

#### **By Javan Flowers**

"We are sleepwalking to climate catastrophe." Cautioned United Nations Secretary-General António Guterres highlighting how Russia's invasion of Ukraine is poised to be an enormous obstacle for the concerted effort to speed up climate action.

The General's address pointed to "a cauldron of challenges" such as record inflation, and the fallout from Russia's war in Ukraine, which risks upending global food and energy markets, "with major implications for the global climate agenda".

He warned that as G20 economies scramble to replace Russian fossil fuel, short-term arrangements might create long-term fossil fuel dependence and close the 1.5 degrees window.

"Countries could become so consumed by the immediate fossil fuel supply gap that they neglect or knee-cap policies to cut fossil fuel use," Mr. Guterres insisted. "This is madness."

As noted in a previous release by the United Nations, fossil fuel reliance continues to put the global economy and energy security at the mercy of geopolitical shocks and crises – adding that inaction will stop the world from achieving sufficient reduction in carbon emission.

The Secretary-General also stressed that according to present national commitments, global emissions are set to increase by approximately 14% during the rest of the decade. Citing that last year alone, "global energy-related CO2 emissions grew by six percent, to their highest levels in history, as coal emissions surged to record highs."

Guterres continued by stating the fact that while developed G 2 0 e c o n o m i e s account for 80% of all global emissions, he underscored that "our planet can't afford a

climate blame game." As he explained, developed countries must not put the onus on developing economias

developing economies to accelerate their transition nor must developing economies respond by saying that "you exported carbonintensive heavy industrial activities to us in return for cheaper goods". Further emphasizing that "We can't point fingers while the planet burns." Towards the end of his address, he insisted that new simplified eligibility systems and increased adaptation and resilience investment be developed, optimized, and adequately funded.

Guterres reiterated the objectives laid out at COP26 and advocated that developed and emerging economies to cooperate with each other for all countries to deliver emission reductions.

"Adaptation and mitigation must be pursued with equal force and urgency adaptation ... investments need to be dramatically scaled up to keep pace with accelerating impacts," emphasized Secretary-General, calling on all donors and technical partners to work with the UN and vulnerable governments.

An independent lab study on AstraZeneca's antibody-based COVID19 drug Evusheld found it "neutralized activity" against Omicron coronavirus variants, including the highly contagious BA.2 subvariant.

The study concluded that "Evusheld retains potent neutralizing activity against the emerging and highly transmissible Omicron SARS-CoV-2 BA.2 subvariant. The data also showed that Evusheld retains activity against Omicron BA.1 and BA.1.1.1." Additionally, "live organism" data gathered using mice infected with Omicron BA.1, BA.1.1, and BA.2 depicted that "Evusheld significantly reduced the viral burden and limited inflammation in the lungs for all three subvariants."

The release further adds that Michael S. Diamond, Ph.D., Washington University, cited that "The findings demonstrate that Evusheld effectively protected against infection in the lungs, a critical disease site for severe COVID-19, across all Omicron subvariants tested."

John Perez, Senior

Vice President, Head of Late Development, Vaccines & Immune Therapies at AstraZeneca, further pointed out that "These important data show that Evusheld reduced viral burden and limited inflammation caused by Omicron."

Perez further highlighted that the findings reinforced support for Evusheld as a potential medication that aims to provide better protection for vulnerable patients such as the immunocompromised, who could see dire health implications if they were to become infected with COVID-19.

# Belize observes World Meteorological Day

Belize joins the rest of the world in celebrating World Meteorological Day, observed on March 23rd, under the theme "Early Warning and Early Action."

Speaking, via video presentation, on the importance of Belize's Meteorological (Met) Service is Chief Meteorologist Ronald Gordon, "One of the things to minimize property damage, and of course safeguarding life, is to have an early warning system of any hazardous weather or climate activity that could negatively affect citizens of the country."

As explained by the Met Service and the Government of Belize, this day commemorates the founding of the convention that established the World Meteorological Organization

tance of having adequate and easily accessible hydrometeorological and climate information to aid in disaster risk reduction and sustainable development.

Deputy Chief Meteorologist Michelle Augustine also further underscored that the frequency and intensity of extreme weather and climatic events have become more prevalent on varying and unprecedented scales across the world due to climate change. Therefore, the Met Service must promptly inform the citizenry p of all potential systems that pose a direct threat to life, property, and livelihoods.

A release issued by the GOB's Press Office emphasizes the importance of producing "impact-based forecasts" as simply providing "what the weather will be, will no longer suffice." This evolution of weather forecasting is to inform the public of what the weather will do, and with that information, the public is expected to respond in an informed manner to safeguard lives and protect property.

Additionally, the release highlights the need to strengthen early warning systems, which are a top priority in most climate change adaptation plans, including improving the coordination between national meteorological and hydrological services, disaster management authorities, and development agencies.

Toward the end of the release, it states that "The National Meteorological Service of Belize in the Ministry of Sustainable Development, Climate Change and Disaster Risk Management continues to fulfill its mission of providing services and products to protect the Belizean public from extreme weather and climatic events."

One night spent sleeping in a moderately lit room, rather than a dimly lit room, can lead to higher heart rate during the night and insulin resistance the next morning, a small study suggests.

The study included two groups of 10 healthy adults. One group slept in dimly lit rooms for two consecutive nights and the other slept in dimly lit rooms one

night and then moderately lit rooms the next, according to the study, published March 14 in the journal Proceedings of the National Academy of Sciences. The moderately lit rooms were illuminated with a 100 lux overhead light, which is about as bright as it would be on an overcast day, according to The Washington Post.

A 100 lux light could also be compared to a lit television screen in a darkened room or a street light shining through a thinly veiled window, New Scientist reported.

All the study participants wore heart monitors to sleep,

and on the second night, the group that slept in moderately lit rooms showed a marked increase in heart rate while they slept, as compared to the night before, the researchers observed. The group that slept in dim lighting both nights showed no significant change.

"We showed your heart rate increases when you sleep in a moderately lit room," Dr. Daniela Grimaldi, a co-first author and research assistant professor of neurology at Northwestern University, said in a statement. "Even though you are asleep, your autonomic nervous system is activated." The autonomic nervous system regulates involuntary bodily processes, such as breathing, heart rate, pupil dilation and digestion, as well as the fight-or-flight response.

If the autonomic nervous system is driving up heart rate during the night,



"that's bad," Grimaldi said. "Usually, your heart rate together with other cardiovascular parameters are lower at night and higher during the day."

The study authors also ran several tests to estimate the participants' insulin resistance each morning of the study, after they awoke. The hormone insulin normally helps cells take in glucose, or sugar, from the bloodstream. But when cells are resistant to insulin, they don't take in glucose as readily, and the body produces more and more insulin to compensate. Over time, cells become resistant to even these sky-high insulin levels, which causes blood sugar levels to soar.

On the first morning, after they'd slept in dimly lit rooms, both study groups scored about the same on the insulin resistance tests. These tests included the

> Homeostatic Model Assessment of Insulin Resistance (HOMA-IR), a calculation that takes fasting insulin and blood sugar levels into account, as well as direct tests of how the body responds to glucose, called an oral glucose tolerance test (OGTT) and the Matsuda insulin sensitivity index.

> On the second morning, the group that slept in the moderately lit room scored worse on these tests, while the group that slept in dim light scored about the same or better as the day before. "Exposure to a single night of [moderate] room light ... during sleep increased measures of

insulin resistance the next morning," the researchers wrote in their report.

This study is limited in that it only included 20 people and only monitored the participants for two days and nights. People shouldn't assume that they need to change their sleeping habits unless these results are borne out in a larger trial, Jim Horne, a U.K.-based neuroscientist specializing in the study of sleep, told New Scientist.

# Why Do Sharks Bite Underwater Cables?



In the search for new subsea oil fields, geologists use large vessels to tow several heavy-duty cables (called streamer cables) to collect seismic data. Equipped with hydrophones that receive the returned signals initiated from a seismic source, these streamer cables are deployed at about 16 - 65 feet deep, and each streamer is typically 26,247 ft long. As one can imagine, this activity probably attracts numerous animals to

check out what the ruckus is all about. One of these animals are sharks, who are attracted to the magnetic streamer fields and tend to bite through the cables! In some areas of the world, equipment loss due to shark attacks on streamer cables is a serious problem in terms of time delays and economic loss for the operator.

In the search for new subsea oil fields, geologists use large vThis isn't the first time sharks

have caused a headache for undersea cable systems- this problem goes back to 1980's! According to Network World, even Google 0.0%GOOGL has had to wrap their internet cables in Kevlar-like material to prevent damaging shark bites. So why are sharks attracted to undersea data cables? It's not exactly known. Some believe that because sharks can sense electromagnetic fields through jelly-filled pores on

their snouts called ampullae of Lorenzini, perhaps they are attracted by this electrical current and confusing it for food. Alternatively, shark expert Dr. Chris Lowe from California State University suggested they may just be curious about them. "If you had just a piece of plastic out there shaped like a cable, there's a good chance they'd bite that too," said Dr. Lowe, who runs the Shark Lab, in the interview to Wired.




Two Heads Fight!

When snakes are born with two heads, they fight each other for food.



Foxes are related to dogs. They're medium-sized, weighing anywhere between 2 and 24 pounds, with pointy faces, lithe frames, and bushy tails.



Foxes are solitary.Unlike their relatives, foxes are not pack animals. When raising their young, they live in small families—called a "leash of foxes" or a "skulk of foxes"—in underground burrows. Otherwise, they hunt and sleep alone.

Foxes have a lot in common with cats. Like a cat, the fox is most active after the sun goes down. It has vertically oriented pupils so it can see in dim light, and it hunts by stalking and pouncing on its prey. The fox also has sensitive cat-like whiskers and spines on its tongue. It walks on its toes, which accounts for its elegant, feline-like tread. The gray fox even has semi-retractable claws, making it the only member of the dog family that climbs trees. It has been known to sleep

in the branches—just like a cat.

Foxes use the Earth's magnetic field. Like a guided missile, the fox harnesses the Earth's magnetic field to hunt. Other animals, like birds, sharks, and turtles, have this "magnetic sense," but the fox is the first one we've discovered that uses it to catch prey.

According to New Scientist, the fox can see the earth's magnetic field as a "ring of shadow" on its eyes that darkens as it moves toward magnetic north. When the shadow and the sound of prey lines up, it's time to pounce.

# Dons, Dealers and Dors

Father Robinson of the Roman Catholic Church is to be commended for the forthright, clear, and public manner in which he laid out the official position of his church on the government's proposal to legalize marijuana use in our country. Like representatives of other denominations who have spoken out on the matter, the Roman Catholic Church unequivocally opposes the Legalization of marijuana use in Belize. It is to be hoped that other religious denominations, including Muslims, Hindus, and Jehovah's Witnesses will also share their views on the matter with our public. It would also be helpful to hear the views of our non-governmental organizations, our trade unions, and our medical experts and scientists. The decisions of our parliamentarians on this emotional topic will impact all our lives and our collective future.

The possession, use, and trade of marijuana have long been viewed as a problem internationally. It is, in fact, the subject of international conventions; including the United Nations Convention Against Illicit Traffic in Narcotic Drugs and Psychotropic substances of 1988. It is also included in both Schedule 1 and VI of the Single Convention on Narcotic Drugs, which prohibits its production and possession except for medical and scientific purposes. Marijuana is a preparation of the cannabis plant used as a psychoactive drug and by some for its therapeutic effects. It is the most

widely produced and consumed illicit drug in the Americas.

Cannabis can grow in any part of the world, outdoor and indoor. While it is produced in nearly every country in the world, Mexico, the U.S., Columbia, Paraguay, and Canada are the largest cannabis producer countries in the Americas. Jamaica and St. Vincent are the largest producers in the Caribbean. Indoor cultivation of marijuana has now increased tremendously. Producers increasingly use sophisticated agronomic cultivation techniques to increase yield, quality, and potency, as well as to breed for other characteristics such as flavor or aroma. Although we in Belize grow marijuana we also import high potency marijuana from Mexico and Guatemala.

While some states in the United States have legalized marijuana possession and use, under the US Federal law both possession and use of marijuana remain unlawful. It is a criminal offense to attempt to export marijuana into the United States. And no Belizean bank that deals with the proceeds of marijuana can have correspondent banking relations with banks in the USA. No Belizean businessman engaging in marijuana cultivation and sale will therefore have access to any of our local banks or credit unions to facilitate their business transactions. The Government of Belize has had a long history of trying to eradicate marijuana cultivation, trade, and use in our country. It has been partnering for decades with the Drug Enforcement Agency of the United States

in this quest as well as with the Organization of American States. Together they have employed a combination of measures to discourage its cultivation and use, including public education campaigns, spraying marijuana plantations with chemicals, as well as using manual labor to cut down and burn growing plants. The Government has also passed draconian laws to punish those involved in the drug trade. In addition, special units of our security forces have been established for the express purpose of

The vast majority of the countries of the world including Mexico, the UK, Canada, China, India, Australia, Japan, and all those in Africa. North and South America criminalize all dealings in marijuana. No investor in the marijuana industry in Belize therefore can ever expect to export the product to any country abroad. Furthermore, no Belizean investor can ever produce better quality marijuana and a larger and more substantial supply than can the United States and Mexico. Internationally and locally, the marijuana trade is a lucrative one. Entrepreneurs in the United States and Mexico earn billions of

who finance the cultivation of the plant, the farmer who plants, tends- and reaps it, the vendor who sells it, and the facilitators, including lawyers, politicians, bankers, public servants, and gas station owners who help to launder the proceeds of the sale of the drugs. Despite the limitations of the information available, it is known that the mark-up on illicit drugs is higher than on legal goods.

Available evidence shows that the illicit drug problem has led to the corruption of government officials at various levels. The illegal drugs economy requires protection, bribery, and collusion, as well as omissions, on the part of civil servants, in order to protect its operations and guarantee that its actions go undetected and unpunished. Indeed, worldwide, the consensus is that the illegal drugs economy and organized crime cannot survive without corruption. Both violence and corruption can only thrive in a context of extensive impunity, in which there is no certainty that the law will be enforced and the state lacks the capacity to identify and try those responsible for breaking the law.

Although there are no available statistics it is fair to say that most Belizeans do not use marijuana or any other drug for that matter. And, the recent decriminalization of possession and use of small quantities of marijuana has not resulted in any perceptible increase in marijuana use by Belizeans. Additionally, relatively few Belizeans seem to develop harmful patterns of use and dependence on marijuana. Most users do so for social or recreational purposes. Few users transition to the use of harder drugs such as cocaine.

The vast majority of Belizeans who are involved in the marijuana trade are youths who have been marginalized and excluded, for one reason or the other, from involvement in legitimate business activities in our country. The historic ignorance, marginalization, and joblessness which they have had to endure, particularly those in urban centers, have conduced to the degradation of characters and the injury of morals among them, and have made them easy prey for drug dealers. It is beyond dispute that the drug industry in our country has been responsible for the epidemic of violence and murders which now characterize our once peaceful, safe nation. Violence and homicides are the collateral damage associated with the cultivation, production, distribution, and sale of drugs and the protection of those criminal activities, and with disputes between rival criminal factions. The drug problem is causing far more deaths, devastation, i and pain to our society than the dreaded Covid-19 Pandemic. And it is seriously undermining those of our institutions that are designed to protect and serve

our citizens and to enhance our well-being and prosperity! It is a scourge upon the poor and powerless in our country and in particular upon our youths.

The evidence is irrefutable that the legalization of marijuana does much more harm than good to the poor and the powerless in those societies where it has been legalized! The majority of our population is poor. Some fifty-two percent are living below the poverty line. Too many of them are the victims of violence and domestic abuse. Too many of them are addicted either to alcohol or some other type of drug. Too many are meeting violent deaths at the hands of professional assassins' agents of drug dons who operate with impunity in our country. The dealers, dons, and dors, easily compromise our political and public service elites making it virtually impossible for them to carry out their duties in the best interest of our country.

Unquestionably, the only ones who stand to benefit from the legalization of marijuana in our country at this time are drug dealers and their facilitators. However, while they may produce it and trade in it lawfully locally, they will not be able to travel abroad to enjoy the profits of the trade. Unquestionably too the harm that will come to our country and to the vast majority of our poor and powerless citizens especially our children will far outweigh any benefit which may accrue to the purveyors of marijuana in our country.





The BTSD Strategic Plan clearly addresses the relevance of taxpayer segmentation and the risk management approach. It indicates that:

"It has become good practice for Tax Administrators across the world to implement Taxpayer Segmentation in revenue management to effectively analyze taxpayer data and to efficaciously implement different and specific surveillance and control mechanisms," and that; "The deployment of a 'Risk management approach' is a modern and pertinent tactic that would aid in compliance. This approach gives a structured basis for strategic planning; focuses on the underlying drivers (not symptoms) of non-compliance; promotes diversity in the way major tax compliance risks are treated, rather than a 'one size fits all' approach; realizes better outcomes as it refers to efficiency and effectiveness of programs; coincides with international standards and is a strong basis for evidencebased evaluation.

Consequently, the BTSD will explore the introduction of a Risk Management Plan (RMP) to properly respond to the risks identified on a timely basis, to minimize overall compliance burden for both the taxpayers and the tax administration. # **Horse Racing in Shuga City**

By Leon C. Guild Competing with the ungulates has been a hosted event since as long as I can remember. On the planet these beasts of burden have long been used for more than just wars and work. They have been a source of entertainment for the dopamine addicts for thousands of years.

The average racehorse can run approximately 40 to 44 mph. A rigidly trained animal can sustain this for less than 20 seconds on average though most horse are unable to go any faster than 20 to 30mph with a rider on its back. The record for fastest galloping speed is 55mph by American Quarter Horses who can only do it while galloping a distance less than 400 meters.

# "You have given us back our smile"

#### Contributed by the Human Rights Commission

Early Wednesday group of men sat under the shade of a large tree while some women conversed quietly on the veranda of a shelter. They were unwinding, relaxing in the warmth of the evening heat. It had been a successful day; a long but successful day. Their applications for asylum in Belize had been accepted.

As we approached, they greeted us with wide smiles, got up and welcomed us with warm hugs. They were content to say the least. They could finally breathe easy following the harrowing ordeal they faced for weeks locked up in prison. Two mothers had been separated from their children and would not know anything about them during this time.

This is a group of migrants from Cuba who journeyed in search of a better life elsewhere. They were caught in the Cayo area on February 7th, detained and a couple days later, imprisoned at the Kolbe Foundation for immigration offences. They have never refuted breaching Belize's immigration laws. As we spoke with them, one of them explained that they were aware of the troubles they could face on their journey as migrants, but none was prepared for what they experienced at the hands of Belizean authorities. Their story is one that must be told. It highlights the systemic abuses of men, women and children by members of Belizean authorities and government departments. It also brings special attention to the unlawful treatment of migrant persons who are denied their civil and political rights. But put simply, these individuals were stripped of their

voice, their dignity and treated with little humanity. It was as if they were invisible, like they didn't matter - not them, not their children.

They shared that upon their arrest they were informed of their rights only to be denied these rights immediately after. None was able to make a phone call to their family or to the Cuban Embassy. None was afforded the right to an attorney. They were kept in a cell with no way of contacting their families back home. They slept on the cold floor.

One person tested positive for COVID-19, was isolated to a corner in a cell along with her daughter but not afforded any followup medical check-up or medication. The following day, six adults were placed into a van and taken to court. One person recalls feeling fearful for her life and said that the officers would not inform them of where they were headed. The children were left behind, along with the one adult who was COVID-19 positive. However, they too were taken out of prison but given her diagnosis, she was charged outside of moment.

But their nightmare was just beginning. They recall asking for their belongings but never received them during their time in prison. They were immediately placed in quarantine for twelve days and had no contact with anyone. Some shared feeling constant desperation and fear being locked up and kept in the same quarters as convicted prisoners, observing and being so close to continuous tensions among these men. It was difficult even to eat, some said. They slept on the floor and had to eat their food without any cutlery. Others were disheartened that no one seemed to be interested in checking up on them. After twelve days, one person from the group was allowed one phone call and it was at that time that they learned that some family members were in Belize looking for them. This was the first time in days they felt hope. It's important to note too that all seven adults had paid their fine but

remained locked up. Meanwhile, the mothers worried about their children and sought assistance from prison officials. Some said they would investigate, but the mothers never received word of their children. They were only able to speak with them on March 17th, a day before their appearance in court; with support from the Human **Rights** Commission of Belize. It was their family members who reached out to the Commission. President of the Commission and attorney Leo Bradley stepped in, met with the group and subsequently sued the government for the unlawful detention of the group.

stating that the "applicants' detention is unlawful because they have been denied the constitutionally protected rights they are entitled to during detention". Even though the respondents, government, argued that the applicants plead guilty to immigration offences and that "incarceration pending removal is reasonable because the applicants were unwilling to consent to repatriation to Cuba and pose a flight risk", the court found that the group was processed and incarcerated without the opportunity to consult with an attorney. The court ordered the group's immediate release, that the children be returned to their parents, and a decision

on damages would be made.

Today, almost one week after, the group is recovering from the ordeal. Their asylum applications have been accepted and they breathe easier. Still, the experience still haunts some of them as they try to recover from the psychological impacts and trauma that remain. The mothers worry still for their children, who are slowly sharing what they faced in the time away from them; and it's not easy to hear. The teenager has shared that he was locked in a cell and treated using the same routine as the other teens at the youth hostel. Meanwhile, the seven-year-old child was returned to her mother with her hair infested with lice.

Still, they remain grateful through it all. They hope others who have been detained for similar offences receive the same help. As we concluded our chat with them, they recomposed themselves and one of them said (in Spanish) "You have given us back our smile, even though we are left with psychological trauma to overcome. We are very grateful."

court. They were all charged, fined, were to be deported back to Cuba and according to them, Immigration officials also requested they serve three weeks in prison.

Before taking the last adult to prison, we are told that authorities first took a teenage boy to the youth hostel. His mother was never informed of his whereabouts. The younger child, a seven-year-old girl, was removed from her mother and handed over to the Department of Human Services. The mother would not know of her daughter's whereabouts or wellbeing after that
