While admitting that the exact increase is yet unknown as it has to be reviewed Cabinet, Shaw promised that he will provide the public with an update by next Tuesday. Shaw, however, told The Reporter that he expects the increase to take effect in a week's time and is, therefore, warning commuters to budget and be prepared.

Witness Protection for Better Justice

The Government has implemented a witness protection program as part of an initiative to fast-track the delivery of justice in Belize, with three new laws passed in the House of Representatives in Belmopan on Tuesday, March 15.

Too often have criminal prosecutions,

especially murder trials, fallen apart when they go to Court due to witnesses' failure or refusal to testify, after they have been intimidated or killed by associates of the accused. The prosecutor has then been forced to enter a nolle prosequi.

Minister of Home

Affairs and New Growth Industries Hon. Kareem Musa introduced the Protection of Witnesses Bill this week. Once enacted, the law seeks to provide for the protection of witnesses in criminal proceedings. The aim is to enhance a witness' ability to give testimony in judicial proceedings and

to cooperate with law enforcement authorities, without fear of reprisals from the accused.

Additionally, the health protocols for prevention of COV-ID-19 transmission had already made it necessary to hold virtual court hearings via tele-conferencing with the judge in his cham

GOB presents Budget for Fiscal Year 2022-2023





Johnny Briceño this week provide the most encouraging grounds for believing that Belize can and will work her way out of debt to become a prospering democracy.

Last year, despite the burden of a Covid epidemic dragging at our heels, the Belize economy rebounded with an unprecedented 12.5% growth, according to the International Monetary Fund.

"It is a progress report unmatched in our 41 years as an independent nation," Prime Minister Briceño exulted in a 46-page budget presentation that promised fiscal reform and help for small and medium-sized entrepreneurs. Moreover, he promised to take measures that would in time bring down interest rates.

The domestic performance was so good that the prime minister congratulated Minister of Agriculture, Food Security, and Enterprise Hon. Abelardo Mai for the impressive growth. Bananas, citrus, sugar, and fisheries all showed robust growth with marine products such as conch and lobster leading the way.

Thanks to a breakthrough with Mexico crossborder trade, cattle and livestock, pigs and poultry did well.

The Prime Minister did not mention inflation in his budget speech, but earlier he made it clear that his government would take vigorous measures against merchants who tried to gouge consumers with inflated prices.

Domestic revenues from taxes and other incomes are expected to bring in \$1.22 billion during the fiscal year starting March 1, 2022, and Belize expects to have a small surplus on its domestic operations to apply to capital projects. Grants from various sources are expected to bring in \$35 million, down from the \$50 million of last year.

Tourism has rebounded and the Belize dollar is no longer facing pressures. The Belize Central Bank's reserves "registered an increase ... that exceeded \$140 million."

The Prime Minister indicated that the government would have to do something about wages and pensions. He noted that 62 cents out of every revenue dollar is used to pay wages, subsidies, and pensions to the tune of \$704 million. This pension program is patently unsustainable, he said, and so a new framework will be needed.

The Prime Minister paid special attention to an agency called the Millennium Challenge Corporation, which is a new foreign aid arm of the US Government involved in providing financial support to micro, small and medium-sized enterprises to reduce poverty in the hemisphere through growth.

Belize is one of two countries in line for grant funding which is expected to come on stream next year. "With a high degree of confidence", the Prime Minister said, "I predict that Belize will benefit from massive new grant flows when these various programs come into gear."

Cont'd from pg. 1 John Briceño on Tuesday, Shaw told The Reporter, "In terms of the bus situation, it is looking really good for us. [It is] not actually what we wanted; it could be better, but we understand that there is a global crisis around the world so in terms of the bus fares there will be some sort of adjustment to it."

According to Shaw, at the meeting which was attended by the prime minister, representatives from the unions, the government, the Belize Chamber of Commerce and Industry (BCCI), and the Governor of the Central Bank among others, they collectively discussed the pressing issue of fuel costs and the impacts on business and consumers. While they all contributed to the discussion on how the increase in fuel will affect the various industries and steps that can be taken to mitigate the overall effect, Shaw said that it was collectively agreed that the bus industry is in need of immediate relief.

"Well, if no consideration is given to the BBA then the bus industry will just come to a halt; operators cannot operate at a loss. So there is no 'but,' 'if' or 'maybe.' There has to be an increase in bus fares. If there isn't any relief at the pumps and no adjustment to the bus fares, then automatically the bus industry will have to close down."

At that meeting, discussions also centered around the overall upgrade of the public transportation system, inclusive of getting relief on importing buses that are less than 10 years and extending bus operators' permits from 2 years to 10 years. This, according to Shaw, will assist bus operators tremendously when they go into the banks to get loans.

While Shaw said that he understands the strain that the price increase is going to put on commuters, he insists that it was something that should have been done years ago.

The agreement between the BBA and prime minister came about following consecutive days of meetings which went through the weekend. That is after the BBA had threatened to shut down the public transportation system if the government did not approve a price increase in fares. The BBA had

Cont'd from pg. 1 bers in Belize City, and the accused remaining at the Kolbe Foundation, and being present only on the television screen.

Now these arrangements have been made legal via an amendment to the Indictable Procedure Act, Chapter 96 of the Laws of Belize, which the Minister of Education, Culture, E-Governance, Science and Technology Hon. Francis Fonseca introduced at Tuesday's sitting.

Having previously served as Attorney General in the previous PUP administration, minister Fonseca was well – versed with the law's provisions but saw need to expand the list of offences for trial without a jury in certain criminal cases.

The Act now also allows for hearings or trials before the court to be conducted virtually, and for additional crimes to be included in a count of an indictment. The order also allows for the Schedules to be amended and provides for other matters "connected therewith or incidental thereto".

Minister Fonseca also introduced and amendment to the Inferior Courts Act, Chapter 94 of the Laws of Belize, to allow for the magistrates Courts to also conduct hearings or trials virtually, with all the necessary provisions.

Analysts: China's COVID resurgence tempered oil prices

A ccording to analysts speaking with CNBC News, China's massive spike in Covid and subsequent lockdowns have helped reduce oil prices from record highs reached a weak ago.

Given that China remains the world's biggest oil importer, any demand reduction would impact global energy prices, as explained by international analysts.

In the initial week of the unsolicited invasion of Russia into Ukraine, crude oil prices saw an enormous hike, reaching over USD\$130 per barrel. However, over the past week, this hike has since significantly retracted partly due to "peace talks" between Russia and Ukraine.

Richard Gorry, managing director of JBC Energy Asia, explained that "The OPEC [Organization of the Petroleum Exporting Countries] in their monthly reports have not changed their demand forecast, which suggests that it is business as normal."

He added, "I would tend to believe that that will probably change in the months ahead, because if we look at China, for example, right now, we have 45 million people under lockdown, like it was in 2020. And we know from history that this does have an impact on oil demand."

Adding to the comments made by Gorry is Ray Attrill, head of foreign exchange strategy at National Australia Bank. In a release, he further adds that "[The decrease in oil prices] more likely reflects a combination of some speculative froth being blown off, alongside fears of weaker China demand as more Chinese cities are put into lockdown amid record-high Covid case numbers."

Notably, Beijing has since imposed sweeping lockdowns as it grapples with its worst COVID spike, which since the pandemic began and has since ordered the suspension of manufacturing in several cities.

GOB presents Budget for Fiscal Year 2022-2023

Prime Minister Hon. John Briceño presented the proposed Budget of BZ\$1.361 billion for Fiscal Year 2022-2023 at this week's sitting of the House of Representatives.

As detailed by Briceño, there was a myriad of factors out of the Government's control that influenced how the Budget was assembled. Such factors included "inflation, interest rates, the cost of fuel and energy, climate change, the terms for trade and commerce, among others."

With regards to revenue and spending, he announced that there would be no "major tax revenue measure;" however, the lotteries sector should expect an "adjustment in collections" as this sector "is not fairly contributing." Additionally, the Government will maintain its current mandate to enforce that those taxes owed are collected aggressively.

Notably, as announced earlier this year, the new Budget restores the wage levels of the public officers and teachers, effective as of July 1st.

Briceño continued by divulging that "Recurrent Revenues" are projected at BZ\$1.122 billion, which is 7.5% (BZ\$86 million) higher than the forecasted outturn for this fiscal year. Both Tax and Non-Tax revenues are projected to rise while Capital Revenues will remain constant, and Grants will fall to BZ\$35 million, in line with our bilateral agreements. Boasting that "revenue growth is consistent with the IMF's 6.5 percent overall GDP growth forecast for 2022 and the Central Bank's slightly more modest 6 percent growth forecast."

With regards to expenditure, he explained that overall spending would rise compared to this year's projected outturn by 12% (BZ\$144 million). These increases will include the following major spending lines:

Wages and Pensions will rise by a combined 10% (approximately BZ\$49 million), most of which is attributable to the 10% wage restoration;

Subsidies and Transfers will increase by 25% (BZ\$37 million), which is indirect wage subsidies linked to the wage restoration;

Debt service will rise by (BZ\$24 million), as interest payments commence on the Blue Bonds; and

Capital Spending will increase by BZ\$30 million compared to this year's outturn of BZ\$243 million.

In summary, therefore, the new Budget targets a Primary Surplus of some 0.35% (BZ\$14 million) of GDP, along with an overall deficit of 2.49% (\$98.1 million) of GDP.

Furthermore, the Government proposes to retire BZ\$97.4 million in public debt during this budget cycle, the total financing of which requires BZ\$195.6 million. This sum will be fulfilled with BZ\$84 million from a portion of a \$150 million loan provided by the (Republic of China) Taiwan; BZ\$98 million disbursements from International Financial Institutions in support of the Nation's Capital II Program; and BZ\$13 million from the domestic system financed through the new issue of Government treasury securities.

Briceño further commented on Belize's 2021 national economic rebound, touting that it "may be as high as 12.5% according to the IMF, twice the rate of the Latin America and Caribbean regions. In fact, Belize is the fastest growing economy amongst all countries in North, Central and South America and the Caribbean."

Such a rebound could be, according to the Central Bank of Belize, attributed to (1) the timely reopening of the economy, (2) a strong vaccination campaign, and (3) a resurgence in agricultural production from weather-related shocks.

In his closing remarks, Briceño emphasized that "If Belize is to grow and develop, all of us must be committed to a strong Belizean economy and society, grounded in credible, practical plans and solutions to the social and economic challenges we face."

Gender Equality —women and girls

Gender equality is the theme of women's month 2022 and the call is to #BreakTheBias. But what is gender equality? How much do we really understand about gender equality?

Truly, there is so much that can be discussed about this topic starting with how it all began, where in our global history gender equality movements achieved advancement, where the struggle is today and what it even costs. Additionally, we can take an entire column to write about the benefits, including the millions of dollars that can be added to the global GDP when women play an identical role in labour markets to that of men. In this space, we hope only to start the conversation in an effort to better understand what gender equality is with a

focus on women. But first, put simply, gender equality is every person (no matter their gender age, socioeconomic status, place of birth, place of origin) having an equal voice, rights, opportunities and responsibilities. This includes economic participation and decision making throughout their lives. According to the United Nations, while the world has achieved progress towards gender equality and women's empowerment under the Millennium Development Goals, including equal access to primary education between girls and boys, "women and girls continue to suffer discrimination and violence in every part of the world."

So, in short, gender equality for women and girls means being able to live in a safe and equal society. They would have equal access to power, resources and opportunities; and be treated with dignity, respect and fairness. But where do all the inequalities start? We say, it starts at home. Here is where children are exposed to gender roles. What is this? Genderroles, also known as sex roles, is the social role boys

and girls are expected to learn, such as behaviours and attitudes determined primarily by prevailing cultural norms. Growing up, boys and girls see gender inequalities at home and communities daily. Dad goes to work while mom stays at home caring for the children and the house, bearing the brunt of caregiving. It can be argued that it starts even before, at birth where gender disparities start out small. In almost every household, blue is thought to be the colour for boys and pink for girls. We see this in their clothes and the toys they are given to play with, all reflecting gender stereotypes – a topic all on its own.

As they grow, children continue to see and experience gender inequalities and these become more socially prominent. UNICEF reports that many girls receive less support in schools than boys, so much so that "worldwide nearly 1 in 4 girls between the ages of 15 and 19 are neither employed nor in education or training - compared to 1 in 10 boys". It adds that "the onset of adolescence can bring significant barriers to girls' wellbeing. Gender norms and discrimination heighten their risk of unwanted pregnancy, HIV and AIDS, and malnutrition. Especially in emergency settings and in places where menstruation remains taboo, girls are cut off from the information and supplies they need to stay healthy and safe. In its most insidious form, gender inequality turns violent. Some 1 in 20 girls between the ages of 15 and 19 – around 13 million - have experienced forced sex. In times of both peace and conflict. adolescent girls face the highest risk of genderbased violence."

It is important to note as well that boys also suffer from harmful gender norms. UNICEF states that "Social conceptions of masculinity can fuel child labour, gang violence, disengagement from school, and recruitment into armed groups."

Depending on where you live, the gender inequalities differ. In some countries, laws still exist that violate women and girls' basic human rights but the work continues to push for gender equality. Now, you may wonder why or how gender equality for women and girls can improve societies. The UN states that "Providing women and girls with equal access to education, health care, decent work, and representation in political and economic decisionmaking processes will fuel sustainable

economies and benefit societies and humanity at large." UNICEF adds that "Reducing inequality strengthens economies and builds stable, resilient societies that give all individuals – including boys and men – the opportunity to fulfil their potential." The discussion on how we can achieve this is, again, something we may need an entire column to explore.

The United Nations estimates that women could "increase their income globally by up to 76 percent if the employment participation

gap and the wage gap between women and men were closed. This is calculated to have a global value of \$17 trillion". Additionally, gender equality builds safer and healthier communities. Unequal societies have higher rates of anti-social behaviour and violence. And since our focus here is on women and girls, gender equality prevents violence against them. Thus, the best way to prevent violence against women is to promote gender equality. We also add that gender equality is important to sustainable

development. According to the UN, "gender equality is not only a fundamental human right, but a necessary foundation for a peaceful, prosperous and sustainable world."

MCC grants Belize US\$750,000 for Poverty Alleviation

The Millennium Challenge Corporation (MCC) of the United States will provide grant funding for projects to alleviate poverty in Belize over the next seven to eight years, MCC's Chief Executive Officer Alice Albright announced in a press conference at the Radisson Fort George Hotel in Belize City on Thursday morning, March 17.

Albright led an MCC team to Belize on Tuesday, and met with Prime Minister John Briceño on Wednesday, March 16, when they signed an initial grant agreement for USD\$750,000 to help the Government set up a project implementation unit to identify development projects and project proposals which will drive economic growth.

Other members of the MCC team have been in the country a couple of weeks now, and they will remain while they do a comprehensive assessment of Belize's economic situation to identify key areas of need for the MCC to focus their investment. Unlike many other international funding agencies, the MCC will not dictate to Belize what priority areas they wish to fund but will let the Belizean people decide how and where development will take place. The MCC team will, therefore, be consulting with both private and public sectors, with civil societies and other interested parties to get a comprehensive overview of Belize's economic situation.

This assessment and consultation process towards a grant agreement to fund projects typically takes two to three years of analysis and planning, Albright explained, as it is a very rigorous process. The MCC experts will seek to identify the key factors which are limiting economic growth in Belize. This is to ensure that the funded projects meet the needs of the intended beneficiaries, the Belizean people, when they are actually implemented, which will be over

a five-year period after the grant agreement or "compact" is signed.

Albright did not quote an exact figure for a grant, but MCC vice president Jonathan Brooks cited the example of El Salvador, where the MCC had identified the quality and access to education as a key factor to improve the economy and had granted USD\$56 million for that project. The MCC is particularly concerned about gender parity and empowering women, and in the case of Georgia - a former state of the Soviet Union, the MCC had implemented programs to improve access to university education and secondary education.

The percentage of people living below the poverty line in Belize has been gradually growing, as indicated in the four poverty surveys which have been conducted between 1995 to 2018, lamented Chief Executive Officer Osmond Martinez of the Ministry of Economic Development. The poverty rate was 52.3 percent in 2018, but the latest UNICEF study of child poverty this year shows that 60 percent of Belizean children are

living in poverty. The reduction of poverty was a declared goal of Plan Belize before the 2020 elections, and it is now the No.1 priority for the Briceño administration, he affirmed.

He thanked the MCC for investing in Belize's economic growth and promised that the private sector would be the main beneficiaries of the project funding, as it is the private sector that will drive economic growth. He admitted that Belize needs to develop its human capital through education, but that said government's goal is to create the enabling environment for entrepreneurs to start-up businesses which will create jobs by also facilitating access to low-cost financing.

Belize is one of only two countries which the MCC has identified for their support this year. The MCC had considered Belize in 2014, but at the time, Belize's economy was doing significantly better and was not deemed to need the MCC's help. The MCC has continued to monitor Belize's economic performance, and the low per capita income prompted the MCC to decide last December 2021 to invest in Belize.

espite the unfortunate death of UDP's Stalwart Herbert Panton, two weeks ago, the UDP's convention, to elect a new leader. which was slated for March 27th, 2022, will not be postponed as had been anticipated.

Panton reiterated that she is more than ready to take on the leadership of the UDP, a role which she considers not only important for the party but for the country as a whole. According to Panton, the opposition needs to be robust and stable in order to hold the Briceño Administration to account and in order to present a viable alternative for good governance to the Belizean people.

We attempted to get a comment from the Hon. Shyne Barrow on how his campaign is coming along since he seems to be having a head start over Panton; however, we are yet to get a response from him. Both Panton's and Shyne's position at the helm of the UDP will be left up to 515 delegates to decide.

Two billion genetically modified mosquitoes approved to be released into the wild

The U.S. Environ-■ mental Protection Agency has approved Oxitec's request to release two billion genetically modified mosquitoes in Florida and California to combat the transmission of harmful diseases such as dengue and Zika.

In a release, the UKbased company stated that "Oxitec's safe, sustainable and targeted biological pest control technology does not harm beneficial insects like bees and butterflies and is proven to control the disease-transmitting Aedes aegypti mosquito."

Furthermore, as detailed in the release, the program aims to reduce cases of dis-



offspring of the Aedes aegypti mosquito, wnich spreads di through its bite.

Scientists at Oxitec facilitated the mass production of the genetically modified male Aedes aegypti eggs in a lab. These male mosquitoes will be released into the wild to "mate with females and pass along a gene that will kill the female offspring." Such a gene is intended to eliminate the female mosquito, which carries

diseases, while leaving the male mosquito and male offspring alive.

It is to note that numerous environmental groups in both California and Florida pointed out that the scientific data presented by Oxitec has not been peer-reviewed and that a release of genetically modified mosquitos of this magnitude would pose tremendous difficulty to undo if it were to affect ecosystems in an unintended manner.

Due to that decision taken for larger profits and ulterior motives by two of the largest companies in the country, if a stevedore's yearly salary was \$24,000, it dropped to less than \$12,000 per year with absolutely no support from either of the two companies to assist the dedicated workers in making up for their last income

Floralia Limited hoping for logic to prevail in the courts

Floralia Limited says that they are still awaiting word from the Department of Transport in relation to an injunction filed last week by the Belize Bus Association (BBA), which seeks to quash road service permits that were issued to the company to commence new runs from Independence Village to Belize.

According to the owner of Floralia Limited, Marvin Vanzie, the runs which were set to officially commence at the start of the week were postponed until next week, not because of any legal issue but because emotions on the ground were running at an all-time high. Vanzie said that after consulting with their legal team it was agreed that moving forward with the new schedule would have been too confrontational and so a pause was the best way to deescalate

the tension.

Vanzie told *The Reporter* that while he hopes that logic will prevail in the court, he is cognizant of the loopholes that can propel the results in favor of the other side. "My point is that you never know what can happen inside of the court," said Vanzie. "But outside of the

court, I can tell you that if all logic prevails, we did everything that we had to do to make sure that we did it legally. We didn't pull any strings or ask for any favors, all the documentations are there and that is why I feel confident that nothing will happen. I mean we are not hiding anything and so they will go

to court and find out that everything was done properly and that the whole procedure was normal."

In response to the BBA's allegations that Floralia's road service permits were awarded illegally and did not meet all the requisite criteria, Vanzie said that the allegations are untrue.

He told us that he had met all the requirements, filed all his documents, and kept following up with the Department of Transport for several months to get a response. He noted that his paperwork was reviewed and vetted by a board, who then agreed that the new company had met all the requirements and thus they would be awarded their road service permit to enter the competition.

Vanzie said that the decision was then gazetted and when it did not meet any pushback from the public, Floralia was finally cleared to commence their runs from Independence Village to Belize.

Vanzie also responded to the BBA's claim that Floralia was "piggybacking" major runs that bus operators had taken years to build. Vanzie referred to that as a "fake reality" and one that he wanted to dispel with the explana-

tion that runs are not "created" and that while his company does have the capacity to convince customers to use their service, they simply cannot manipulate an entire economy. He stressed that in the end it is left up to a customer's own free will to use their service of choice as well as their need to get to a particular destination for a particular time.

Vanzie said that he can safely say that the company's success at this point is based on hard work and determination by staff that has labored to create the best possible service to their paying customers as well as the company's resolution to provide reliable, comfortable, and clean buses to the public.

In closing, Vanzie reiterated that while Floralia awaits the outcome of the injunction that is before the courts, their old runs will continue uninterrupted.

NEAB Still Objecting to Legalization of Marijuana

The National **⊥** Evangelical Association of Belize (NEAB) has once more come out to place on record their disapproval of the proposed legalization of marijuana in Belize on the basis that the industry will open the door for additional influences and harm to the country, its people, and businesses.

NEAB, along with its associated c h u r c h e s countrywide, stated that they continue to be in "strong opposition'" to the legalization. They say that the new Bill also has the government not only legalizing, but promoting the production, sale, and use of marijuana.

The Reporter spoke to one of NEAB's members, Pastor Louis Wade, who made reference to two incidents last week which made headlines and which involved children using drugs and being recorded. Wade said that all this was being done simultaneously while the Government was making plans to legalize marijuana, without putting the requisite safeguards in place for the protection of children. He referred to a part of the legislation that seeks to make edibles legal, a move which he said can prove to be damaging to the younger population who are now closer to accessing these products through parents or loved ones at home.

"Since we have already seen all these social problems that exist already, we should be moving to reduce [as opposed to] moving to enhance. And if we do more to legalize, what we are saying is that nothing is wrong with this substance; therefore, we are encouraging t h e increase consumption and use thereof. And that is why the church cannot and will not endorse this move and that is why we are moving in the opposite direction. Our children should inherit a drug-free society and not a society where drugs are more readily available for them," said Wade.

In their press release, NEAB also noted the need to "shut the door rather than open it to marijuana dealers, many of whom also sell harder drugs. If this bill passes, we can expect increasing serious harm to come to our youth,

business, tourism, and international banking relations."

The release argued that the more profitable the marijuana business becomes the more drug cartels and their powerful militaries will be involved. They made reference to the increase in cartel crimes in neighboring Mexico and the impacts that it has had on tourism.

NEAB said that they will be the first to sound the alarm on the effects that they believe a move like this will cause on the country and even fear that once allowed will be nearly impossible to root back out.

They also pointed to the fact that being that other neighboring countries have not legalized Marijuana, Belize will now have the potential to become a major transshipment point for marijuana and other big-time drug runners.

In closing, NEAB claimed that the country already has great potential for recovery and prosperity without resorting to the inevitably demoralizing and corrupting marijuana business and instead should aim for a more healthy and beneficial course.



Pandemic's E-commerce Surge Proves Less Persistent, More Varied

There's no doubt that e-commerce helped many navigate the pandemic, from online shopping to curbside pickup to food delivery. But as we slowly emerge from lockdowns and other restrictions, it's less clear how this shift to digital commerce may evolve across economies and industries.

This raises questions about how much digital consumption increased, whether the crisis widened the digital divide or spurred economies with little e-commerce to catch up, how permanent the shift to online sales will be, and what factors explain deviations between economies and sectors.

We investigated these questions in new research that uses a unique database of aggregated and anonymized transactions through the Mastercard network from across 47 countries from January 2018 to September 2021. We found that the share of online spending rose more in economies where e-commerce already played a large role—and that the increase is reversing as the pandemic recedes.

This research, a new partnership between Mastercard, the International Monetary Fund and Harvard Business School, shows how private-sector data can help advance empirical economics and will be the first in a series of such studies.

Variation across economies

On average, the online share of total spending rose sharply from 10.3 percent in 2019 to 14.9 percent at the peak of the pandemic, but then fell to 12.2 percent in 2021.

Though the latest online share of spending is higher than before the pandemic started, it's only 0.6 percentage points above the growth trend for e-commerce had the crisis not happened. While most economies are now below those peak levels, there are still significant differences among countries.

The online share of spending is still above prepandemic trends in about half of economies, from large emerging economies such as Brazil and India to other middle-income countries like Bahrain and Jamaica. In all the others, including the United States and many advanced economies, the online shares are now either at or below the predicted pre-COVID trend levels. Those trends are estimated in each economy using a simple extrapolation of

e-commerce's path before the pandemic and reflects what would have been predicted in the absence of the crisis.

We find that e-commerce increased more in economies with a higher pre-COVID share of online transactions in total consumption, exacerbating the digital divide across economies. For example, Singapore, Canada and the United Kingdom had high shares to begin with, and their online penetration went up even more during the pandemic. On the other hand, countries like Brazil and Thailand had low online shares pre-COVID, and they experienced less of an acceleration.

How persistent was the effect on online sales? Strikingly, the latest data suggest that the spikes in online spending shares are gradually dissipating at the aggregate level.

The average online spending share at the peak of the crisis was 4.3 percentage points above the level that would have been predicted before it hit. This difference drops to only 0.3 point by the end of our sample period.

Pandemic restrictions, fiscal support

One explanation for the variation across economies, and in online share of spending, may be the difference across pandemic-related mobility restrictions. Not surprisingly, economies with stricter limits saw much higher online spending.

This was particularly true at the beginning of the crisis in the second quarter of 2020, when lockdowns severely curbed movement in most economies. However, as the pandemic continued, that correlation between restrictions and online spending weakened—consistent with the declining impact of lockdowns and other restrictions on economic activity over time.

In addition, fiscal support during the pandemic helped boost e-commerce penetration, likely by increasing consumption, which, in the presence of pandemic restrictions, could mostly be done online. Wealthier, more digitally mature economies also returned faster to pre-pandemic pace of online spending once the crisis receded.

Longer-lasting effects

One common narrative is that the pandemic accelerated digitalization, forcing consumers to learn how to shop online, and that this learning was here to stay. While our results support the quick uptake of e-commerce, the persistence of learning does not appear broad-based.

That said, we find significant variation by industry. The embrace of e-commerce appears to be particularly longer lasting in restaurants (more specifically in food delivery), health care (which includes telemedicine) and some categories of retail, including department stores, electronics, and clothing.

During the initial surge of the pandemic, there was a big demand for e-commerce relative to inperson commerce. Economies and sectors already familiar with some of the technologies were able to go online to a larger degree. While the pandemic forced consumers to learn quickly, our results suggest that early adopters further extended the use of e-commerce within their economies.

Further, there are two possible explanations for differences in the embrace of e-commerce across industries. First, this could reflect that mobility hasn't fully recovered, along with the in-person nature of some sectors such as dining. Second, digitalization in these same sectors wasn't particularly high before the pandemic, and those were the areas where COVID-19 propelled the shift the most.

The share of online spending rose and fell most dramatically in those economies and sectors where e-commerce was already thriving before the pandemic. Industries with lower levels of digital maturity—including retail, restaurants, and health care—have greater potential for e-commerce, particularly in less developed markets, making them potentially ripe for change.



No Excuses

A Good Country

he Right Honour-**L** able Said Musa, former Prime Minister of Belize once said; "Belize is a good country." Perhaps it was an understatement and he could have elaborated, but he was absolutely correct and 'dead on the money.' Belize ostensibly is a true tropical paradise, but it has a major problem: and that is its politics, which has also contaminated many of its people.

But the physical aspect of the country is amazingly superb. Its location, smug in Central America and washed by the beautiful and bounteous Caribbean Sea is ideal. Its climate is one in which there are no great extremes, e.g. Its temperature is constant within a relatively narrow range; it has the largest barrier reef in the entire Atlantic Ocean, second only to the great barrier reef of Australia. With such a reef it is home to a wide variety of living marine organisms. There are numerous fishing banks with large numbers of different species of fish; then there is lobster, shrimp, conch, crab, rich nourishing seaweeds, and seagrass to provide food for the marine herbivores, all of which becomes a food source for us.

There are the mangroves whose roots help to hold the soil together and prevent erosion plus it provides nursery and protection for young hatchlings - before they venture out into the deeper open waters. There are numerous marine birds that enhance the beauty of the marine environment. In addition to all this, the sea provides for recreation such as boating, i.e. sailing, steaming, sport and commercial fishing, swimming, snorkeling, scuba diving, picnicking, and residing at the numerous cayes with their sandy beaches and the blue and turquoise waters and fresh sea breezes cooling down the heat from the land. We still have quite a bit of forest which is so essential to life, and ours is a tropical forest that is so bountiful with its high degree of productivity. It allows for high production of rich pure oxygen in a clear unpolluted sky, and at the same time allows for carbon dioxide sequestration for its photosynthetic activity.

The forest also provides wood for building homes and is used in cooking. The advantage here is that trees that are cut can be replanted for sustainability. The forest is home to many game animals and wild birds which are used for food. It is to the credit of different governments to have and maintain forest reserves. Except for Guyana, the other Caribbean territories virtually lack forests of any significance. Our forest also provides watersheds for our water supply needs. There are numerous year-round rivers due to the topography of the land and the forest watersheds.

Water that is so essential for life is needed for drinking, cooking, washing, removal of waste, both body waste and sullage ie waste from bathing, cleaning, mopping, doing the dishes, etc. The rivers house, a variety of fish, turtles, freshwater crayfish all used to provide for food, transportation, navigation, and recreation viz: boating, swimming, and fishing. There are also many wetlands with a wide variety of birds species inhabiting them as well as many lagoons suited for recreation such as fishing and swimming etc.

Then they are many areas of the country that are rich in agricultural lands. This is expressed in the wide variety of fruits and vegetables available. This includes coconuts with their healthy refreshing water and the meat for coconut milk for cooking and sweet delicacies; the wide varieties of mangoes, plums, soursop, cashews (with their nuts), custard apples, avocado pears, citrus fruits, watermelons, cantaloupe, pineapples, berries, etc. Many vegetables like tomatoes, peppers, okra, green leafy vegetables of all sorts, cucumbers, beets, pumpkins, chochos, rice, corn beans of different types, legumes, ground tubers, roots etc. Then there are different animals used for meat: chickens, ducks, turkeys, pigs, cattle, sheep, goats, and so on. Added to all this is a relatively small population with its rich cultural diversity.

The result is incursions from the neighboring countries ex-

some 20% of Belize population made up of "aliens" its population is now about 400,000 people. Guatemala's about 17,000,000, El Salvador or about 7,000,000 Honduras about 10,000,000 and Nicaragua about 7,000,000 i.e. some 40,000,000 immediately around us. We are not counting Chinese, Asians, Africans, and Europeans.

With all our Godgiven resources our people don't seem to realize all that we have. They don't appreciate "the wealth untold." Instead, our people complain, beg,

In the old days, Belize was a calm pleasant society people were more mannerly, respectful, decent, and friendly. One would wish and hope that the people of Belize would realize the God-given gift of a wonderful country like Belize:

ploiting our resources. These incursions not only involve taking, clearing, and occupying our land, but are also causing our population to increase with the resultant illegal cutting down of our forests and exploiting our fish stocks. It is also causing an increasing demand on our social resources such as educational, medical, police, prison overcrowding, human social resource systems. The incursions are for the most part by poor immigrants, very many thousands of them who are seeking a better life (otherwise they would not come).

The Government of Belize (GOB) has received financing from the Inter-American Development Bank (IDB) for the execution of a five-year tax modernization project entitled "Strengthening of Tax Administration" (BL-L1031). Through this project, the Belize Tax Service Department (BTSD) has procured a Modern Integrated Tax Administration System (the Revenue Management System (RMS) and is presently in the implementation process. This new system will be used in the management of the Belize Tax Administration.

The BTSD Strategic Plan clearly addresses the relevance of taxpayer segmentation and the risk management approach. It indicates that:

"It has become good practice for Tax Administrators across the world to implement Taxpayer Segmentation in revenue management to effectively analyze taxpayer data and to efficaciously implement different and specific surveillance and control mechanisms," and that; "The deployment of a 'Risk management approach' is a modern and pertinent tactic that would aid in compliance. This approach gives a structured basis for strategic planning; focuses on the underlying drivers (not symptoms) of non-compliance; promotes diversity in the way major tax compliance risks are treated, rather than a 'one size fits all' approach; realizes better outcomes as it refers to efficiency and effectiveness of programs; coincides with international standards and is a strong basis for evidence-based evaluation.

Consequently, the BTSD will explore the introduction of a Risk Management Plan (RMP) to properly respond to the risks identified on a timely basis, to minimize overall compliance burden for both the taxpayers and the tax administration. As an important aspect of the RMP, risk mitigating strategies will be proposed for application against potential and existing risks. The plan will highlight all areas of risks including risk-based assessments, risk-based audits, risk-based sector and taxpayer segmentation, compliance risks (registration, filing, reporting and payments) and international risks. Risk mitigation reduces the extent of exposure and ensures that the strategic objectives are achieved."

The consulting services ("the services") includes the contracting of a Consultancy Firm for a period of five (5) months to review and update the current Taxpayer Segmentation and develop a Risk-based compliance management model, including configuration of the model in the ITAS. The main activity of the consultancy includes:

- 1. To prepare an Action plan for the review and updating of the Taxpayer Segmentation Model and Risk Analysis Strategy

- 6. To include the information on taxpayer segmentation in the ITAS database, inclusive of defining (setting) the parameters and rules for its then configuration in the ITAS database.
- 7. To prepare a report on the risks identified as well as the relevant mitigation measures to be introduced.
- **8.** To suggest additional information (internal and external) to improve its risk-based control system.
- **9.** To deliver workshops to BTSD staff on the Taxpayer Segmentation Model and risk analysis strategy to be implemented.

Belize plans to manage Water resources

elizeans can no Dlonger afford to take our ample freshwater resources for granted, as the recent drought of 2019 demonstrated, and farmers drawing on underground water for crop irrigation during a drought must consider that they are drawing on an aquifer that is also used by Mexico and Guatemala, Principal Hydrologist Tennielle Williams Hendy warned.

Williams explained the dynamics of managing Belize's water resources, when the Ministry of Natural Resources, Petroleum and Mining launched its \$1.8 million project to develop a National Adaptation Plan for sustainable water management at the Best Western Biltmore Plaza Hotel in Belize City last Thursday afternoon, March 10.

The project aims to benefit the most vulnerable population: Belize's farmers, who lost millions of dollars in crop damages when rivers burst their banks and flooded their fields, and millions more in losses from failed harvests caused by droughts. Climate Change has not only altered rainfall patterns and thrown farmers' planting seasons out of kilter. It has also had multiple impacts on Belize's water resources, as sea level rise means the contamination of un-

derground freshwater aquifers with salt water, and the increasing salt level in the Belize River estuary is already making Belize Water Services plan to relocate the water intake for the water treatment plant at Double Run, which supplies Belize

City.

The project will work in partnership with the Caribbean Community Climate Change Center (CCCCC) in Belmopan to develop a national climate adaptation plan to manage Belize's water resources in a sustain-

able manner, explained Ministry of Economic Development's Chief Executive Officer Osmond Martinez. The project will develop a learning framework for managing our water resources, along with a national monitoring and evaluation system for all Belize's rivers, lagoons and streams water resources. Local academia will be invited to collaborate in monitoring coastal sea levels and water resources to gather better information for improved decision making to adapt to climate change impacts. The project will also develop a concept note of the adaptation priorities of the water sector within the management plan.

Belize is not alone in its fight against the effects of Climate Change, as the Green Climate Fund offers help to developing nations to adapt and mitigate Climate Change impacts, explained Belize's GCF focal point Leroy Martinez

Belize has access to \$10.8 billion to which the Fund has raised in pledges from 48 nations to conform to the Paris Agreement, when the United Nations Framework Convention on Climate Change UNFCCC established the Fund in 2010. The fund finances projects to reduce carbon emissions an also mitigation projects to improve resilience to Climate Change, and the public and private sector and civil organizations can also submit project proposals to get GCF funding.

Projects submitted by the private sector or civil societies must conform to national priorities, and must first be approved by the National Designated Authority—CEO Osmond Martinez, and the GCF focal point within the ministry—to be considered for GCF financing. The GCF may provide a grant or a loan on concessionary terms, or in the form of technical assistance.

The Caribbean Development Bank and 5 C's are regional entities already accredited to the GCF, as is the Protected Areas Conservation Trust (PACT). The

Development Finance Corporation, the Social Investment Fund and the Ministry of Economic Development are also seeking GCF accreditation.

Hydrologist Tennielle Williams explained that persons planning to drill a well for water are required by law to first obtain a license from the Ministry of Petroleum and Mining. They have to determine the rate of water flow from the aquifer they tap into and whether it will meet their needs for the amount of water they plan to extract, and whether it will be sustainable for the groundwater to be replenished naturally by rainfall over time. The need for a water management plan has become urgent, as the best climate change projection indicate the rainfall will decrease progressively over all regions of the world. It may be hard to imagine now, but water will become more valuable than oil!

Belizeans must learn how to conserve water and to properly dispose of garbage to avoid contamination of the water supply. This means not dumping garbage down an empty well which has gone dry, as the waste may still leach harmful chemicals into the underground water supply. The plan will include a public education component to bring everyone in sync with the national goals. Belizeans must be prepared for the economic impact of natural disasters that are related

to water. Providing safe, potable water for everyone, particularly the rural population in the villages, is a complex problem and 5C's stand ready to help, affirmed Keith Nichols, the head of Project Development and Management Unit at 5C's. As an accredited entity of the GCF, 5C's is equipped to prepare projects for up to US\$50 million in GCF financing. In the case of other small islands where rainfall has been reduced, the center has helped with water desalination projects powered by solar, as desalination is expensive in terms of power consumption.

Social Security Board Announces Implementation of the Contribution and Benefit Increase

Social Security Board (SSB) introduces the final phase of the Contribution Reform. The final contribution and benefit increase, which falls under the 3-year phased approach, aims to improve and provide greater value to beneficiaries during time away from work if they become incapacitated or ill.

This is essential for the strengthening of the SSB program in order to provide sickness, maternity, disablement, invalidity, injury, death benefit and pensions to contributors, their families and survivors.

Under the final phase, employers and employees will see an increase of 1% in the Contribution Rate from 9% to 10% and \$480 to \$520 in the Wage Ceiling effective Monday, April 4, 2022. This translates to an increase in the maximum cash benefit of \$416 weekly for short term benefits and \$312 weekly or \$16,224 yearly for pensions.





The longest human necks!

In Western culture, a long neck can appear regal, feminine, and dainty. However, in other parts of the world, primarily a tribe called Padaung located in Myanmar and northern Thailand, it's a custom.

The women of the Padaung tribe in Myanmar and northern Thailand hold the record for having the longest necks in the world. The country that's famous for its islands and amazing street food also features women who bind their necks to make them appear longer!

It's been an age-old custom for young girls - even before puberty - to start wearing iron coils around their necks. They start with just a few, and more and more are added over the years to give the appearance of a long neck.

The women of the Padaung tribe hold the record for the longest neck in the world. As far as this world record goes, they really stick their necks out.

The longest recorded neck length is 15.75 inches long. Record-keepers base



this measurement on the distance between the earlobe and the collarbone. The average neck length of a Padaung woman is 10 inches, which is double the average length of a human neck.

Before we dig into whether or not you can make your neck longer, let's explore the phenomenon.

While it may seem that the neck itself is stretching, it's not. For a long time, experts thought that it was actually the distance between the vertebra that was stretching and lengthening. After researching the women with the long necks—complete with x-rays

— they found something different.


The neck itself isn't stretching, however, the collarbone and the ribs are pushed down. Therefore, this make the longest neck in the world an optical illusion. It appears as though the neck itself is stretched, when in actuality the supporting structures of the collarbone and the ribs push down. This makes the appearance of a much longer neck.

Therefore, the women who have the longest necks actually have the most pushed down collarbones and rib cages, creating the image of a long neck. To

physically lengthen the neck would cause paralysis and death.



Giant penguins once roamed the planet. The first bird actually called a penguin was the now-extinct Great Auk found in the North Atlantic. Tragically, early explorers and their contemporaries found Great Auks a little too tasty, and the birds were all killed off.

Fossil evidence shows that penguins evolved before the dinosaurs died out, and there are remains of giant, people-sized, prehistoric penguins.

The world's smallest penguin stands just over 30cm high.

You'll only find wild penguins in the Southern Hemisphere. All wild penguins live in the Southern Hemisphere, and although they are synonymous with the ice, only two species live on the continent of Antarctica. The Galapagos penguin

is the only penguin that ever naturally ventures into the Northern Hemisphere on especially long feeding trips.

Penguins' black and white 'tuxedo' helps them avoid predators Most penguins have black backs and a white belly. This makes them harder to see from above because they blend in with the dark ocean beneath them. And looking from below, their white underside matches the bright sky overhead.

Penguins use some clever tricks to help them move faster. To move fast through the water, penguins use a technique called porpoising. To move quickly over the ice, they switch to tobogganning. Curiously, porpoises neither use toboggans nor do they use the word penguin as a verb.

There are five basic human senses: touch, sight, hearing, smell and taste. The sensing organs associated with each sense send information to the brain to help us understand and perceive the world around us. However, there are in fact other human senses in addition to the basic five that you couldn't live without. These lesser-known senses include spatial awareness and balance. Here's how the human senses work.

TOUCH

Touch is thought to be the first sense that humans develop, according to the Stanford Encyclopedia of Philosophy. Touch consists of several distinct sensations communicated to the brain through specialized neurons in the skin. Pressure, temperature, light touch, vibration, pain and other sensations are all part of the touch sense

and are all attributed to different receptors in the skin.

Touch isn't just a sense used to interact with the world; it also seems to be very important to a human's well-being. For example, touch has been found to convey compassion from one human to another, according to a study published by the University of California, Berkeley.

Touch can also influence how humans make decisions. Texture can be associated with abstract concepts, and touching something with a texture can influence the decisions a person makes, according to six studies by psychologists at Harvard University and Yale University, published in the June 24, 2010, issue of the journal Science.

SIGHT

Sight, or perceiving things through the eyes, is a complex process. First, light reflects off an object to the eye. The transparent outer layer of the eye called the cornea bends the light that passes through the hole of the pupil. The iris (which is the colored part of the eye) works like the shutter of a camera, retracting to shut out light or opening wider to let in more light.

"The cornea focuses most of the light. Then, it [the light] passes through the lens, which continues to focus the light," explained Dr. Mark Fromer, an ophthalmologist and retina specialist at Lenox

Hill Hospital in New York City.

The lens of the eye then bends the light and focuses it on the retina, which is full of nerve cells. These cells are shaped like rods and cones and are named for their shapes, according to the American Optometric Association. Cones translate light into colors, central vision and details. The rods translate light into peripheral vision and motion. Rods also give humans vision when there is limited light available, like at night. The information translated from the light is sent as electrical impulses to the brain through the optic nerve.

People without sight may compensate with enhanced hearing, taste, touch and smell, according to a March 2017 study published in the journal PLOS One. Their memory and language skills may be better than those born with sight, as well.

"Even in the case of being profoundly blind, the brain rewires itself in a manner to use the information at its disposal so that it can interact with the environment in a more effective manner," Dr. Lotfi Merabet, senior author on that 2017 study and the director of the Laboratory for Visual Neuroplasticity at Schepens Eye Research Institute of Massachusetts Eye and Ear, said in a statement.

HEARING

This sense works via the complex labyrinth that is the human ear. Sound is funneled through the external ear and piped into the external auditory canal. Then, sound waves reach the tympanic membrane, or eardrum. This is a thin sheet of connective tissue that vibrates when sound waves strike it.

The vibrations travel to the middle ear. There, the auditory ossicles — three tiny bones called the malleus (hammer), incus (anvil) and stapes (stirrup) — vibrate. The stapes bone, in turn, pushes a structure called the oval window in and out, sending vibrations to the organ of Corti, according to the National Library of Medicine (NLM). This spiral organ is the receptor organ



for hearing. Tiny hair cells in the organ of Corti translate the vibrations into electrical impulses. The impulses then travel to the brain via sensory

People retain their sense of balance because the Eustachian tube, or pharyngotympanic tube, in the middle ear equalizes the air pressure in the middle ear with the air pressure in the atmosphere, according to the International Journal of Audiology. The vestibular complex, in the inner ear, is also important for balance, because it contains receptors that regulate a sense of equilibrium. The inner ear is connected to the vestibulocochlear nerve, which carries sound and equilibrium information to the brain.

Have you ever listened to a recording of your voice and thought it didn't sound like you? This is because some qualities of your voice sound different to those around you as you speak. For someone standing next to you, the sound of your voice will be detected as it is channelled through their ear canals, according to the BBC. The same will happen in your ears, but as the speech is being produced from within you, vibrations will also reach your eardrums via another route.

When your vocal cords make the noise, the vibrations travel up through your skull to reach your eardrums. As the waves move through bone, they stretch out more to become lower in pitch. Combined with the external sound waves, the outcome is a voice with a slightly different tone to what others hear.

SMELL

Humans may be able to smell over 1 trillion scents, according to the National Institutes of Health. They do this with the olfactory cleft, which

is found on the roof of the nasal cavity, next to the "smelling" part of the brain, the olfactory bulb and fossa. Nerve endings in the olfactory cleft transmit smells to the brain..

Dogs are known as great smellers, but research suggests that humans are just as good. Research published in the May 11, 2017, issue of the journal Science suggests that humans can discriminate among 1 trillion different odors; it was once believed that humans could take in only 10,000 different smells.

"The fact is the sense of smell is just as good in humans as in other mammals, like rodents and dogs," John McGann, a neuroscientist at Rutgers University-New Brunswick in New Jersey and the author of the new review, said in a statement. The Rutgers study backs up a previous study at the Rockefeller University in New York, whose

> findings were published in the March 2014 issue of the journal Science.

> Humans have 400 smelling receptors, according to the Monell Chemical Senses Center. While this isn't as many as animals that are super smellers have, the much more complicated human brain makes up for the difference, McGann said.

> In fact, poor smelling ability in people may be a symptom of a medical condition or aging. For example, the distorted or decreased ability to smell is a symptom of schizophrenia and depression, according to the journal Schizophrenia Research.

> Old age can also lessen the ability to smell properly. More than 75% of people over the age of 80 years may have major olfactory impairment,

according to a 2006 paper published by the National Institutes of Health.

TASTE

The gustatory sense is usually broken down into the perception of four different tastes: salty, sweet, sour and bitter. There is also a fifth taste, defined as umami or savory. There may be many other flavors that have not yet been discovered. Also, spicy is not a taste. It is actually a pain signal, according to the National Library of Medicine (NLM).

The sense of taste aided in human evolution. according to the NLM, because taste helped people test the food they ate. A bitter or sour taste indicated that a plant might be poisonous or rotten. Something salty or sweet, however, often meant the food was rich in nutrients.

Taste is sensed in the taste buds. Adults have 2,000 to 4,000 taste buds. Most of them are on the tongue, but they also line the back of the throat, the epiglottis, the nasal cavity and the esophagus. Sensory cells on the buds form capsules shaped like flower buds or oranges, according to the NLM. The tips of these capsules have pores that work like funnels with tiny taste hairs. Proteins on the hairs bind chemicals to the cells for tasting.

This magnified image shows oval-shaped taste buds on the tongue. (Image credit: Getty Images)

It is a myth that the tongue has specific zones for each flavor, according to NLM. The five tastes can be sensed on all parts of the tongue, although the sides are more sensitive than the middle. About half of the sensory cells in taste buds react to several of the five basic tastes. The cells differ in their level of sensitivity.

Each has a specific palette of tastes with a fixed

Newsprint Paper Price up by 23%

Grace Kennedy Limited, the only remaining importer of newsprint paper for Belize, has increased the price of its paper from \$1.157 a pound to \$1.4286 a pound, for a hike of 23.9 percent.

The increase has caught newspapers in Belize by surprise because it came without warning of any kind.

The hike, when General Sales Tax is added, takes

the new price of one pound of newsprint to \$1.61. Newsprint prices, like other manufactured commodities, have been expected to increase because of a contraction in demand. Paper factories have cut back on production, and also because of the war over Ukraine, which has impacted supply lines.

But the newsprint imported by Grace

Kennedy Limited comes overland from Mexico, so the 23 percent increase has come as a shock.

Newspapers that are already reeling from the 2-year accumulated effect of Covid, are now faced with rising costs which will almost certainly affect their ability to stay afloat.

Mr. Harry Lawrence, Publisher of the Reporter, this week appealed to the business community to do more to support independent newspapers by way of advertising to sustain and preserve this traditional voice of Democracy in Belize.

"In dependent newspapers are needed in Belize more than ever," Lawrence said, "to provide balance and informed commentary on current events."

The five (and more) human senses

(Con't from page 22) ranking, so some cells may be more sensitive to sweet, followed by bitter, sour and salty, while others have their own rankings. The full experience of a flavor is produced only after all of the information from the different parts of the tongue is combined.

The other half of the sensory cells are specialized to react to only one taste. It's their job to transmit information about the intensity—how salty or sweet something tastes.

Other factors help build the perception of taste in the brain. For example, the smell of the food greatly affects how the brain perceives the taste, according to the journal Flavour. Smells are sent to the mouth in a process called olfactory referral. This is why someone with a stuffy nose may have trouble tasting food properly. Texture, translated by the sense of touch, also contributes to taste.

Medically known as glossitis, a burnt tongue is classed as a first-degree burn but quickly heals in a few days, according to the Cleveland Clinic. But taste buds don't completely die when exposed to piping-hot foods.

When we scold the surface of our tongues we remove the top layer of cells, including the upper layers of our taste buds. However,

within the bundle of flavour-detecting cells are stem cells known as basal cells. Typically replacing the gustatory receptor cells every ten days or so, these regenerative cells morph into replacement receptors quickly, restoring your taste. According to the journal Archives Italiennes de Biologie, 10% of cells are new to taste buds each day.

THE SENSE OF SPACE

In addition to the traditional big five, there is another sense that deals with how your brain understands where your body is in space. This sense is called proprioception.

Proprioception includes the sense of movement and position of our limbs and muscles. For example, proprioception enables a person to touch their finger to the tip of their nose, even with their eyes closed. It enables a person to climb steps without looking at each one. People with poor proprioception may be clumsy and uncoordinated.

Researchers at the National Institutes of Health (NIH) found that people who have particularly poor proprioception through

mechanosensation the ability to sense force, such as feeling when someone presses down on your skin may have a mutated gene that is passed down from generation to generation. That comes from a September 2016 study in the New England Journal of Medicine. "The patient's version of [the gene] PIEZO2 may not work, so their neurons cannot detect touch or limb movements," Alexander Chesler, a principal investigator at the National Center for Complementary and Integrative Health and the lead author of the study, said in a statement in The New England Journal of Medicine.

ADDITIONAL SENSES & VARIATIONS

There are more subtle senses that most people never really perceive. For example, there are neuron sensors that sense movement to control balance and the tilt of the head. Specific kinesthetic receptors exist for detecting stretching in muscles and tendons, helping people to keep track of their limbs. Other receptors detect levels of oxygen in certain arteries of the bloodstream.

Sometimes, people don't even perceive senses the same way. People with synesthesia can see sounds as colors or associate certain sights with smells, for example.

San Pedro to get a modern Hospital

In his budget speech this week, Prime Minister Johnny Briceño disclosed that the Government of Taiwan is providing a grant of US\$ 16.6 million (\$33.2 million Bz) for the design and construction of a new hospital for Ambergris Caye.

Construction work is expected to begin this year. The new hospital will have 45 beds and will occupy 28,000 square feet of space. It is being

billed as a state-of-theart facility to provide primary and secondary care.

This will be San Pedro's first full-service hospital. Until now the Island tourism powerhouse has subsisted on a full-time clinic known as the San Pedro Polyclinic and on doctors from Belize Medical Associates in Belize City who fly out regularly for consultative work and for diagnoses.

Update on Status of San Pedro Water System

Belize Water Services apologises to customers in San Pedro for the ongoing low water pressure and outages in the entire San Pedro water distribution system.

Unfortunately, on Friday February 25, 2022, there was a major mechanical malfunction at the Water Treatment Plant, whereby one of three drive trains became non-operational due to a damaged gearbox. This 1,000lb gearbox had to be expedited to the US for repairs. We are pleased to report that the repaired gearbox has arrived back in the country and has been rushed out to San Pedro for installation. However, due to the depleted storage, the company will need to continue with reduced water pressure and planned late night interruptions for several days in order to maintain minimum storage levels to allow supply during peak hours.

BWS assures the public that this situation will be resolved well before the upcoming Easter Holidays, when the demand increases even more.
